Sr. No.	Observation	Reply / Clarification
1.	It appears from your above quoted letter that the violation has been carried out by Municipal Corporation before the submission of the proposal for diversion of forest land under FCA, 1980. In this regard, you are directed to refer to Handbook of FCA guidelines (MoEFCC, 2019), para 1.21 Expost factc approval and Penal provisions and submit your response as per these guidelines.	In this regard it is submitted that, as per documents submitted by the User Agency, the construction activities have been carried out during the year 1996 in 1.5717 ha of forest land. The Penal NPV Bill for 1.5717 ha of violated forest land has already been uploaded against the Additional Information Detail in Part II. Copy of the same is enclosed herewith.

It is therefore, requested that the necessary approval for the diversion of 2.9696 ha of forest land for the construction of above mentioned project may kindly be obtained from the Govt. of India under Forest (Conservation) Act, 1980 and conveyed to this office.
