This is with reference to the subject cited above. In this connection it is submitted that we have attended the shortcomings noticed in above proposal. The observations have been corrected as per your requirement. The Point wise reply to the observations is as under:-

Sr. No.	Deficiencies	Compliance to the Deficiencies
1	In response to observation no. 8, State Govt. has replied that, 'There is no need to take approach road as the proposed site is along with the existing road.' However, the Hon'ble NGT, Principal Bench, New specifically mentioned that "No construction of any kind, i.e., residential, commercial, institutional or otherwise would be permitted within three meters from the end of the road/national highways in the entire State of HP, particularly, in Shimla Planning Area." Since the proposed site is along with the existing road, therefore the comments in this regard in the background of the direction/ order passed by Hon'ble NGT as mentioned in ibid para may be provided.	The existing road along with the proposed site is not a National Highway neither MDR, its approach road to District Court and also proposed site is already three meters away from the existing road. Also NOC from HPPWD has been uploaded online against Additional Information Detail and is enclosed herewith in quadruplicate.

It is, therefore, you are requested that the proposal may please be forwarded to the concerned higher office at the earliest.
