The Chief Conservator of Forests (T) Pune vide reference 2 has also brought to the notice that the proposed land at village Vanhangaon, Tal-Maval, Distt-Pune includes private Forests, Gut No 55 admeasuring area 2.92 ha (Old S No. is 63) and Gut No 56 admeasuring area 3.55 ha (Old S No 64). The Old Survey No's 63 and 64 at Vahangaon figures in the list of Private Forest as per records available in division office. Even 7/12 extracts (other rights) of revenue department mention that the above said land is private forest.

3. The lands are not restored as per the records available with this office and also the user agency has not produced any documents or preferred any claim regarding the restoration of said land under section 22 (A) or release under section 6 of the Maharashtra Private Forests (Acquisition) Act 1975.

4. Therefore as per section 3(1) and 3(3) of the said act, the legal status of the said land is Reserve Forest acquired and vested with the State Government free from all encumbrances.

In view of the above, it is requested that Government of India may kindly be moved to issue approval order under section – 2 of the Forest (Conservation) Act, 1980,
