 Private land owners adjoining the proposed land have not agreed to give their private land for road purposes. (Notarized Certificate copy attached)

The enclosure villages and malki lands are encircled by Reserve Forests. The non forest use of these lands need diversion as per Forest (Conservation) Act, 1980. In the present proposal the approach road is essential to connect to the main road and the malki lands. This is the barest minimum land required and there are no alternate roads.
