#### **Question No.2**

# Whether the instant proposals was examined in view of the recent guidelines with respect to violation provision:

**Reply**: It has been reported that, the authorized signatory, M/s Jio Digital Fibre Pvt. Ltd. has submitted a representation stating that, M/s Jio Digital Fibre Pvt. Ltd carried out the OFC work without knowing that the area falls in Reserve Forest. The work was executed during 20<sup>th</sup> to 31st July 2018 as per the permission accorded by the Executive Engineer, R&B, Guduru to lay OFC from KM 14/0 to 29/0 Km vide Lr.No.EE-GUDUR/ APRCRP001619/ GUDURU/D No.001145, dt.05-07-2019.

It was further reported that, the permission was granted by way of accepting Bank Guarantee of Rs.14,62,500/- to lay OFC cable along the Naidupet to Sriharikota (via) Duggarajupatnam road from Km 14/0 to 29/0 on right side in SPSR Nellore district through HDD method. The bank guarantee shall be valid for a period of one year in terms of G.O Ms. No. 12 dt. 28-7-2014 of ITE&CD (Communication wing)".

As per the above letter of EE,R&B, Guduru, the permission was accorded to M/s JIO Digital Fiber Pvt Ltd, for laying OFC along Naidupet to Sriharikota (via) Duggarajapatnam Road in SPSR Nellore on obtaining Bank Guarantee from the said user agency. In the above reach, some of the portion falls in Puduru RF, Chillamur beat of erstwhile Venkatagiri Range now under the jurisdiction of Tirupati division..

Hence, the said Forest Beat Officer is responsible for the violations and accordingly an Article of Charges was framed against Sri R.Suman, (presently working as FSO, Kavali Range) for the violations during his tenure in Chillamur





Further, we would like to submit that the above work carried out in Puduru RF was purely unintentional and shall pay the penalty if any as per the guidelines, abide by the Forest Act.

In view of the above, we kindly request you to further process our proposal for forest clearance at the earliest.

- 5. Sri R.Suman, Forest Section Officer, is further informed that if he does not submit his written statement of defense on or before the date specified in Para-3 above further action will be processed based on the material available.
- 6. Attention of Sri R. Suman, Forest Section Officer, is invited to Rule 24 of the A.P., Civil Services (Conduct) Rules 1964, under which no Government Servant shall bring or attempt to bring any political or outside influence to beat upon any superior authority to further his interest in respect of matters pertaining to his service under the Government. If any representation is received on his behalf from another person in respect of any matter dealt with in these proceedings it will be presumed that Sri R. Suman, Forest Section Officer is aware of such representation and that it has been made at his instance and action will be taken against him for violation of Rule 24 of APCS (Conduct) Rules, 1964.

## ANNEXURE-I ARTICLE OF CHARGE

STATEMENT OF ARTICLE OF CHARGE FRAMED AGAINST SRI R. SUMAN, FOREST SECTION OFFICERM SPECIAL DUTY, KAVALI RANGE EARLIER WORKED IN CHILLAMUR BEAT OF VENKATAGIRI RANGE ALONG WITH IMPUTATIONS AND MISCONDUCT.

Sri R.Suman, Forest Section Officer, Special duty, Kavali Range of Nellore (T) Division. During his tenure in Chillamur beat of Venkatgiri Range from 25-11-2024 to 18-07-2019, he has committed irregularities, for which the following Article of Charge is framed against him as per the evidences adduced in the statement of imputations and misconduct, against each article of Charge:

ARTICLE-I:

That the said Sri R.Suman, Forest Section Officer has exhibited gross neglegence of duty in stopping the work of "laying of OFC by M/s Vindhya Tele Links Ltd, Secunderabad along Naidupet to Sriharikota (Via) Duggarajapatnam Road from 0 Km to 14.00 KM in SPSR Nellore" and also "laying OFC by M/s Reliance Jio Infocom Ltd.in the same RF and location" and not booked a forest case in the Reserve Forest area which is in contravention to the provisions of A.P.Forest Act, 1967, and Forest (Conservation ) Act, 1980 resulting enormous loss to forest wealth.

#### Statement of imputations and misconduct:

The Sri Srinivasulu, M/s Vindha Telelinks and M/s Reliance Jio Infocom Ltd. have submitted separate representations stating that, M/s Vindhya Telelinks and M/s Reliance Jio Infocom Ltd carried out the work as per the permission accorded by Executive Engineer, R&B, Gudur and permission letter of Executive Engineer,R&B, Gudur vide Lr.No.EE-GUDUR/APRCRP000903/GUDUR/D.No.000376 dated.05-06-2018 and EE, R&B, GudeLr. No.903/JTO/Roadcutting/2019-20 dt. 8-7-2024.

As per the above letters of Executive Engineer, R&B, Gudur, the permission was accorded to M/s Vindhya Tele Links Ltd, Secunderabad and also to M/s Reliance Jio Infocom Ltd forlaying of OFC along Naidupet to Sriharikota (Via) Duggarajapatnam Road from 0 Km to 14.00 KM in SPSR Nellore. In the above reach, some of the portion falls in Puduru RF, Chillamur beat of erst while Venkatagiri Range. Both the companies laid the OFC in the same place one above the another.

Under Section 4 of A.P. Forest Department Code, the services of Forest Beat Officers are classified under protective staff. Therefore, he is responsible for the above OFC work done in RF areas without prior permission from competent authority. The Forest Beat officer is failed to prevent the laying of OFC in the said Reserved Forest by both the companies.

As per circular instructions issued by the Prl.Chief Conservator of Forests, A.P., Hyderabad in Rc.No.23211/995/X3, (Circular No.13/95), dataed.12.11.1995, "A Forest Guard shall inspect his beat thoroughly at least once in a week and not more that 10 days". However, vulnerable areas shall be inspected more frequently. If the Forest Beat Officer had followed the circular

instruction, he could have detected and booked the cases on illegal laying of OFC in RF area by both the companies. But, he has violated the circular instructions of the Prl. Chief Conservator of Forests, AP, Hyderabed.

If he had been frequently inspecting the natural forests in his beat jurisdiction and carrying out beat inspections promptly and perfectly, he himself could have detected laying of OFC in RF area by both the companies without prior permission from competent authority, Forest Beat Officer has neither reported the above incidence to his higher officials nor taken any effective steps to prevent the laying of OFC in RF area. Further, the Forest Beat Officer has not booked any Forest case against the said two companies. Thus, he has neglected his legitimate duties and miserably failed to control and protect the valuable forests, Hence, Sri R. Suman, Forest Section Officer is totally responsible for laying of OFC in RF area by both the companies in RF area without prior permission from competent authority
