SITE INSPECTION REPORT NOT BELOW THE RANK OF DCF  
(for the forest land to be diverted under FCA)

A proposal has been received by this office from Project Manager, Sewage Pollution Control unit  
Municipal Nigam, Rudrapur, U.P. for diversion under FCA-1980 ) of ----- ha. of forest  
land non-forestry purpose. The Project envisages the use of forest land for construction  
of Sewage Pumping Station near Rudra Complex (Below H.P. Bend), under Rudrapur sewerage  
scheme. The site inspection of the land involved in the proposal has done by me on dated
