In reference to the letter cited above, I am to furnish herewith the details extent of violation, name & designations of officials prima facie found guilty and action taken report by User Agency as follows:-

1. Extent of violation

As reported by RCCF, Koraput Circle vide Memo No.1769 dated 08.06.2022(Copy enclosed as Annexure-A,A1,A2,A3), the extent of violation is 369.61 Sq. meter or 0.04 ha against installation of 5 No. of web towers in Tarlakota PRF.

2. Name & Designations of officials prima facie found guilty

As reported by RCCF, Koraput Circle vide Memo No.1769 dated 08.06.2022(Copy enclosed as Annexure-A3), the User Agency has applied for the regular forest diversion proposal on dated 11.10.2020. Further, it has been reported that the above construction work was executed during the period of Sri Laxmikant Panda, Ex-DGM (Elect.), EHT (Const) Division, OPTCL, Jeypore and the exact date of start of work in the forest area was 07.03.2019.

3. Action Taken Report



This is for favour of kind information and necessary action.






