Proposal for diversion of 6.56 ha. of Forest Land for construction of Bolangir By-pass Road (west) by the Executive Engineer, NH Division, Bolangir. (Proposal No. FP/OR/ROAD/141584/2021)

In inviting a kind reference to your memo No. cited above on the captioned subject, the point-wise compliance report under Sl. No. (1) to (10) as sought for vide your memo No. 13051 dtd.02.07.2022 pertaining to the above diversion proposal basing on the compliance submitted by the DFO, Bolangir Division, is furnished hereunder for favour of your kind information and necessary action.

Observation No.1:-The Pages of the DP are not correctly numbered.

Compliance: In compliance to the above, all pages in the DP are correctly numbered i.e. from 01 to 108.

Observation No.2:-Land Schedule: - The diversion proposal is for 6.56 ha. of forest land and 62.59 ha. of non-forest land but while scrutinizing the land schedule area of forest land mentioned for Bolangir and Puintala Tahasil is (6.4099 ha + 0.1477 ha) of 6.56 ha. whereas in non-forest land i.e. Govt. and Pvt. Land is 60.466 ha. (Govt. land 13.860 + Pvt. Land 135.553 = 149.413 Acre) for Bolangir Tahsil. There is shortfall of 2.124 ha of non-forest land which needs to be clarified.

Compliance: In compliance to the above, the details of forest land & non-forest land involved

in the project is furnished below.

Observation No.3:-Tree Enumeration- As per Part-II and Site Inspection report of the DFO, Bolangir Division at Page No.18-23/DP and Page No.24A/DP respectively, the abstract tree list shows that the number of trees enumerated in forest area is 1507 Nos. including 332 Nos. of poles under 30 cm girth and 37 Nos. of bamboos and over non-forest Govt. land over 8 Nos. of villages found to be 2871 Nos. out of which under 30 cm girth (pole) 628 Nos. There is no information about tree enumerated in non-forest land. Hence, the detailed tree enumeration list Tahasil wise and village wise for both forest, non-forest & private land have to be enclosed.

Compliance: In compliance to the above, the following Nos. of trees enumerated in both in Forest and Non- Forest Land under Bolangir & Puintala Tahasils.

Observation No.4:-Alternate Route Alignment- Alternate route alignment study and finalization of route to be enclosed since it is a linear project and as mandated.

<u>Compliance</u>: In compliance to the above, a Map showing alternate route alignment received from the DFO, Bolangir division is enclosed as <u>Annexure-III</u>.

Observation No.5:- Non-forest land- Total non-forest land required for the project has been shown to be 62.59 ha. over 8 nos. of villages under 2 nos. of Tahasils in Bolangir and Puintala. Tahasildar Bolangir has submitted separately non-forest Govt. and Pvt. Land. But there is no record of Puintala Tahasil.

<u>Compliance:</u> In compliance to the above, the total non-forest land under **Puintala Tahasil** is furnished below.

Non-forest Govt. Land= 3.44 Ac Non-forest Pvt. Land= 41.75 Ac

Total= 45.19 Ac or 18.288 ha

Observation No.6:- Certificate regarding Land schedule as on 25.10.1980- Both the Tahasildar, Bolangir and Puintala have not submitted the certificate of land schedule pertaining to their Tahasils required for this project as on 25.10.1980 (Sabik Kisam).

Compliance: In compliance to the above, the Tahasildar, Bolangir and Puintala has submitted the land schedule as per Hal & Sabik kisam as on 25.10.1980 vide memo No.3903 dtd.14.07.2023 and No.489 dtd.24.02.2023 respectively to the DFO, Bolangir division which may kindly be considered as per clarification issued in letter No.21643/ACS R&DM dtd.16.06.2023 of the Additional Chief Secretary to Government & DM Department, Govt. of Odisha. Copy enclosed as *Annexure-IV*.

Observation No.7:- Undertaking for payment of additional NPV is not as per proper format. Compliance: In compliance to the above, an undertaking for payment of additional NPV in proper format submitted by the DFO is enclosed as Annexure-V.

Observation No.8:- CA Scheme- The copy of CA land allotment order by Collector, Bolangir has not been enclosed. Further, CA land map on cadastral sheet of village Sindurabahal of patch-1 has not been submitted.

Compliance: In compliance to the above, the copy of Alienation Order Sheet of the Collector, Bolangir of Compensatory Afforestation Land (Patch-I= 17.290 Ac. or 6.997 ha and Patch-II=17 Ac. or 6.879 ha.) duly signed by the UA & DFO is enclosed as Annexure-VI & Annexure-VI(A). Further, CA land map on cadastral sheet of village Sindurabahal of Patch-1 is enclosed as Annexure -VI(B).

Observation No.9:- The length and width of the proposed road alignment passing through forest and non-forest land has not been mentioned in the DP.

Compliance: In compliance to the above, the length and width of the proposed road alignment passing through both Forest and Non-forest Land submitted by the DFO is furnished as Annexure-VII & Annexure-VII(A).

Observation No.10:- The GPS co-ordinates of the start point and end point of the road project has not been mentioned on the detailed note of the project.

Compliance: In compliance to the above, The GPS co-ordinates of the start point and end point of the road project is enclosed as Annexure-VIII.
