Further, it is submitted that, the above said proposal was verified on the field and with this project there is no threat to the local flora, fauna and the proposed Forest area does not fall in any wildlife sanctuary/ National park, Eco Sensitive Zone and there are no archaeological sites of importance and no historical monuments in the said area. In the proposed area the User agency did not carry

out any work in violation of the provisions of FC Act and other relevant acts and rules and also there is no tree felling involved in the proposed project. The proposed Road is useful in facilitating the transportation to the interior villagers and as there is no direct loss to the Forest and Wildlife. Hence, the proposal recommended for diversion and the User Agency submitted proposals along with Part-II information under Forest Conservation Act, 1980 for diversion are submitted in 4 sets for taking further action in this matter.
