**REPORT****BUILDING FOR MULLAPERIYAR POLICE STATION**

The building is proposed to be constructed as a semi-permanent structure. The main structure is proposed to be constructed as a steel frame with steel columns and steel trusses. The roofing is proposed with powder coated GI sheets and MS tubular reapers.

The wall will be constructed with GI frames covered on both sides with cement fibre boards. The doors will be with pressed steel and windows are proposed as aluminum structure. No masonry /permanent walls will be constructed.

Total plinth area of the semi-permanent building is 3712 sqft.
