

8	There are two numbers of patches are marked for CA but in Part I, the detail is provided for only one patch. The State Govt may provide separate detail for individual patch in the designated column in Part I.	CA details at Section -L -ii in Form A Part I by User Agency.
9	Copy of ownership proof, MoU signed between User agency and the present owner and copy of non encumbrance certificate regarding area proposed for CA is not uploaded in the designated place of Part I.	Correction has been done at section L (iv-f,g,h) in Form A, Part-I.
