

This is with reference to the above proposal. In response to the observations of the IRO, MoEF & CC Jammu, the requisite documents have been uploaded by user agency and DFO Marwah Forest Division. The point wise detail is given as under:-

Sr. No.	Content of the EDS	Action taken
i.	As per FSI-DSS analysis, one ha area out of proposed 6 ha for undertaking CA, is moderately dense forest (canopy density of 40%-70%) and approx. 2.90 ha is under mature/middle height trees/vegetation as per Google earth image. Hence, revised CA site of only 10-40% vegetation needs to be submitted with sufficient vacant space to accommodate the target plantation.	Revised CA plan has been uploaded under column 13(ii) in Part-II by DFO Marwah
ii	The DGPS map, SOI toposheet and Site suitability certificate of revised CA site, accordingly may be modified.	<ol style="list-style-type: none">i.
