Sub: Proposal for seeking recommendation of Standing Committee of NBWL/SBWL an extent of 51.32 ha for construction of Tumkur Branch Canal of Upper Bhadra Project in BukkapatnaChinakara Wildlife Sanctuary Tumakuru District from VishveshwaryaJala Nigam Limited-reg.

With the reference to the above cited subject, Vide ref (2) Deputy Conservator of Forests, Tumkur Division, Tumkur has applied online application No. FP/KA/ Canal/ 37818/2018 proposal Principal Chef Conservator of Forests, (Forest Conservation) and Nodal officer (FCA) Bengaluru has EDS raised is as follows “As per Van Samrakshan Evam Samvardhan Adiniyam 1980 rule 13 the non forest land or portion thereof provided by the UA is not fit for raising Compensatory Afforestation of a specified density, then additional CA shall be raised on a degraded notified or unclassed forest land under the management control of the Forest department which is twice in size such shortfall in the given CA land and the UA shall also bear the additional cost on such account”.

Therefore Executive Engineer, VJNL, Upper Bhadra Project, Division No.09 Sira has requested that provide the twice the extent of degraded forest land to carry out plantation activity in the division.

The Deputy conservator of Forest, Tumkur Division, Tumkur has directed Range Forest Officer, Gubbi Range, Gubbi to identiy the Suitable degraded forest land for Compensatory Afforestation and submit the report.

The Range Forest Officer, Gubbi Range, Gubbi along with staff has identified 122 Ha degraded Forest land in Sy No. 4,5,7,8,9 of Nayakanahalli, Sy. No. 36, 43 of Dasappanahalli & Sy No. 16, 17 of Rangapura village in Ankasandra Reserved Forest Hagalawadi Hobali, Gubbi Taluk, Tumakuru District and submitted the maps, report to office of Deputy Conservator of Forests, Tumkur Division and same has been forwarded vide reference (2).


I have personally visited the above area and has 122.00 Ha of degraded Forest lands. The area is suitable for raising of compensatory afforestation. I agree to the Deputy Conservator of Forests Tumkur regarding identifixation of Compensatory Afforestation area recommended for afforestation.

The User Agency has submitted the undertaking regarding payment of charges on compensatory afforestation and additional amount of compensatory afforestation for the forest land proposed for diversion.

In view of the above facts and circumstances, the identified 122 Ha degraded Forest lands KML File, Google Map, Topo Map, CA land Suitability Certificate in Format-B, Scheme for compensatory afforestation are herewith enclosed for your kind perusal and taking action.

In lieu of forest land division of 51.72 Ha, the proposal of Deputy Conservator of Forests, Tumkur Division, Tumkur regarding 122 Ha of degraded forest land for Compensatory afforestation KML File, Google Map, Topo Map, CA land Suitability Certificate in Format-B, Scheme for compensatory afforestation Required information / documents are here with enclosed for your kind perusal and further needful action.
