

Consolidated reply to the observations of the MoEF & CC letter
No. 8-07/2021-FC dated 10.03.2021 is furnished as under:-

1. DFOs Shimla, Karsog and Kotgarh have revisited the KML file of
the area proposed for CA and necessary correction w.r.t. corrupted
file/ missing/ overlapping of the area has been rectified. After doing
corrections fresh KML files uploaded on the portal.
2. All the DFOs i.e. Shimla, Karsog and Kotgarh have submitted and
uploaded enumeration list of the trees at FRL-2 meter and FRL-4
meter level alongwith species wise girth wise details.
3. User Agency has submitted the documents to be uploaded exceed
the 20 MB limit of the portal and as per discussion held in the
Ministry these documents have been uploaded on the official e-mail
AIG, MoEF & CC, New Delhi.
4. The site inspection reports of CCF Shimla and Mandi have been
uploaded as part of the documents. Hard copies already provided in
the proposal folder.
5. Copy of approval of the CAT Plan is enclosed. As the documents is
more than 20 MB. The copy of the approved CAT plan has been
submitted to AIG, MoEF & CC, New Delhi through email.
6. The User Agency has submitted the R & R plan to the competent
authority (copy enclosed).

7. The site suitability certificate of all the CA sites have been uploaded. The hardcopy of all CA site already provided ^{except} ~~except~~ CA site Theog Forest Division by DFO Karsog, copy of which is enclosed.
8. Necessary correction in the CA areas have been done and now no CA proposed on non forest land. Necessary correction have been done online.
9. As per provision of para 2.5 (i) f. of the FCA guideline handbook 2019 the projects implemented by the Central Government/ PSU, excluding Central Govt./ Central PSUs Projects implemented by/ through State Government and State Sector Projects implemented by the Central Government/ PSUs. The user agency exempted from providing certificate of Chief Secretary.
10. The scientific name of species does not appear in the drop down online portal. Hence the same is mentioned in the column of local names in brackets.
11. Cost benefit analysis prepared by the user agency as per latest guideline have been submitted alongwith internal rate of return.
12. Note of justification of locating project has been uploaded through email. Hard copy enclosed.
13. Approved DPR is a huge documents comprising of thousand documents. Soft copy has been submitted on email to MoEF.
