

It is submitted that, the Principal Chief Conservator of Forests & HoFF, Andhra Pradesh, Mangalagiri has issued instructions vide reference 1st cited to direct the user agency to identify suitable non-forest land for CA purpose to an extent of 9.74 ha and instructed to furnish the details along with DGPS maps of the CA land for taking further action in this regard.

Further, the user agency has submitted a letter vide reference 2nd cited, stating that, they have identified balance non-forest land for CA in Sy.no.1787 over an extent of 2.54 acres / 1.027 ha in Peddannavaripalli village, Talupula mandal, Sri Satya Sai District of Kadiri Range, Sri Satya Sai Division.

In this connection, a letter was addressed to the District Forest Officer, Sri Satya Sai Division, Puttaparthi, vide reference 3rd cited, for furnishing of the CA area afforestation proposals along with Site Inspection Report, Soil Suitability certificate, authenticated DGPS maps etc.,

Accordingly, the District Forest Officer, Sri Satya Sai Division, Puttaparthi, has submitted the CA scheme details vide the 4th reference cited above. Upon verification of the report submitted by the District Forest Officer, Sri Satya Sai Division, and the representation submitted by the user agency, it was observed that the total land extent had been mistakenly considered as 10.69 ha, whereas the actual forest land involved in the proposal is only 9.74 ha. Further, the extent of CA land was also noted as 10.69 ha instead of 10.70 ha.

Accordingly, a letter was addressed vide the 7th reference cited above to the District Forest Officer, Sri Satya Sai Division, Puttaparthi, requesting submission of the revised CA scheme. Subsequently, the District Forest Officer, Sri Satya Sai Division, Puttaparthi, submitted the revised CA scheme vide the 8th reference cited above, and the Conservator of Forests, Ananthapuram, approved the same vide the 9th reference cited above.

Further, the Principal Chief Conservator of Forests & HoFF, Andhra Pradesh, Mangalagiri, issued instructions vide the 5th reference cited above for submission of the factual position of the M/s Bhaskara Minerals project.

In this connection, it is submitted that, a reply to the query raised in the PARIVESH portal was submitted on 29-05-2026, duly uploading the revised CA scheme furnished by the District Forest Officer, Sri Satya Sai Division, Puttaparthi, in the PARIVESH portal. Further, the proposal was forwarded to the Chief Conservator of Forests, Rajahmundry, through the PARIVESH portal on 29-05-2026.

The user agency i.e. M/s Bhaskara Minerals, Kakinada, East Godavari District identified the non-forest lands in Sri Sathya Sai Division & District for diversion of forest land for mining lease for laterite over an extent of 9.74 Ha (Mining- 7.38 Ha, Road-1.50 Ha & Safety Zone 0.86 Ha) in Compt. No.606 of Sarlanka RF of Kakinada Division, in favour of M/s Bhaskara Minerals, Kakinada, East Godavari District. The non-forest land details are as below.

AREA :-

The User Agency has identified the non-forest land towards Compensatory Afforestation over an extent of 10.70 Ha will be treated for Raising Compensatory Afforestation Plantation with the funds to be deposited by the User Agency towards cost of C.A. **The area is adjacent to the Kokkarajukonda, Gorivikanuma, Nigidi & Gorivikanuma Addl. Block-VI Reserve Forests.**

The non-forest land proposed to be treated is suitable for raising of plantation with species like Hardwickia binata (Narepi), Pterocarpus santalinus (Red Sanders), Dalichandron crisper (Neeruddi), Holptelia integrifolia (Thapasi), Azhadiracta indica (Neem), Ficus species etc. The area will be demarcated by construction of boundary Pillars.

OBJECTIVE :-

The main objective of the scheme is to compensate the loss due to the diversion of forest land and to afforest the area and protect the soil from soil erosion besides encouraging ecological balance.

C.A. Area – Semi Mechanical Method:-

TECHNIQUE :-

The proposed CA land is having good natural vegetation, hence it is proposed to raise the plantation by adopting **Semi Mechanical Method** over an extent of **10.70** Ha with excavating the 0.45 M x 0.45 M x 0.45 mt size pits at 3M x 3M espacement after uprootal of stumps. Plants raised in 6" x 12" size bags will be planted and the cultural operations will be carried out over an extent of 10.70 Ha.

PROJECT PERIOD:-

It is proposed to implement the scheme from 2027-28 to 2048-49 over a period of (22) years.

FUNDING AGENCY:-

The total Financial outlay of **Rs.220.171 lakhs** will be met by the User Agency i.e., M/s Bhaskara Minerals, Kakinada, East Godavari District who will deposit the funds with the Forest Department.

EXECUTIVE AGENCY:-

The Forest Department will be the implementing Agency for this scheme.

FINANCIAL OUT LAY :-

The area of 10.70 Ha identified by the user agency in 5 survey number as mentioned in Para-1 will be treated with the CA scheme as enclosed. It is estimated that for Raising of Plantation under Aided natural Regeneration Method over an extent of 10.70 Ha an amount of Rs.220.171 Lakh is required. The User Agency has to deposit the Compensatory Afforestation amount which will be utilized for Raising Compensatory Afforestation plantation over **10.70** Ha suitable area.

The attention of the Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh, Mangalagiri is invited to the reference 3rd cited (copy enclosed), wherein the AIGF(Central), GoI, MoEF&CC, IRO, Vijayawada has informed that the User Agency has identified non-forest land for Compensatory Afforestation(CA) purpose to an extent of 9.67 ha. only as against the proposed diversion of 9.74 of forest land. It may be noted that as per the guidelines issued under Van (Sanrakshan Evam Samvardhan) Adhinyam, 1980, the provision of raising CA shall be applicable for the entire forest area proposed for diversion including the forest area located in the safety zone.

2. The AIGF(Central), GoI, MoEF&CC, IRO, Vijayawada has also informed that as per sub-rule (8) of rule 16 of Van (Sanrakshan Evam Samvardhan) Rules, 2023, any provisions of extant rules will be applicable on the proposals which are yet to be granted 'In-Principle' under the Adhinyam. As per rule 10(2) of Van(Sanrakshan Evam Samvardhan) Rules, 2023, the proposals for mining shall be examined and disposed by the Central Govt. (MoEFCC). Site Inspection of proposals specified in rule 10(2) by the Regional Office is to be submitted to Ministry.
