- 2. In this connection, it is submitted the observations raised by your office memo under reference have been attended by the user Agency as well as DFO Pangi. The point wise reply to the observations as raised is given as under:-
 - 1. Necessary correction in online part-I against column No. A-1 (vii) has been made by the user agency.
 - 2. Necessary correction has been made in online part-I against appropriate column by the user Agency.
 - 3. Needful has been made against column No. B- 2.3 in online Part-I.
 - 4. Necessary correction has been made in online part-I against appropriate column by the user Agency
 - 5. Cost benefit analysis duly signed by the DFO Pangi is placed in the proposal folder also copy of same has also been uploaded on the portal.
 - 6. FRA certificate along with proceedings duly attested by SDM, Pangi has been placed in the proposal folders the copy of same has also been uploaded on the portal.
 - 7. Detail of working plan prescription has been given by the DFO Pangi in online part-II against appropriate column.
 - 8. The total trees involved in the proposal up to FRL, FRL -2 and FRL -4 has been mentioned in the online portal-Part- by DFO concerned.
 - 9. The KML file uploaded as patch sr. No. 2,4 & 9 have been corrected and KML file of Sr. No. 13 has been revised for 21.28 hectare proposed CA area and uploaded.

- 10. Patch wise CA scheme has been prepared by DFO Pangi, and has been uploaded on the portal against appropriate column.
- 11. NPV bill calculation has been made as per the latest guidelines. The copy of same has been placed in the proposal folder also is uploaded on the MOEF portal against additional information.
- 12. Necessary correction in the district profile has been corrected in the hard copy and in online MOEF portal.
- 13. Density of proposed CA area has been has been mentioned in the site suitability certificate and copy has been uploaded on MOEF portal.
- 14. All the photocopies of documents place in the proposal folder have been attested by the User Agency or concerned DFO.
- 15. As the Govt. of India instructions, the PDF of all the documents of hard copy of proposal folder have been uploaded in a single (part-wise) pdf files by the user agency in online Part-I.
- 16. The detail of number of trees mentioned against column No. 7(vii) has been corrected by the DFO Pangi.
- 17. DFO Pangi has submitted that muck dumping site involves 1525 number of trees of above 10cm dia. 296 number of trees are of above 30cm dia and felling of trees shall be taken as per actual requirement, and practice to save the maximum number of trees at the dumping site shall be made during the construction activities.
