उपर्युक्त विषयक प्रसंगाधीन पत्रों के क्रम में सूचित करना है कि मधुबनी जिलान्तर्गत भारतमाला परियोजना के तहत उमगाँव-कलुआही (0.000-21.610 कि०मी० NH-227L) साहरघाट-रहिका (0.000-26.135 कि०मी० NH-227J), एवं विदेश्वर स्थान-भेजा(0.000-25.915 कि०मी० NH-527A) के चौड़ीकरण एवं सुदृढीकरण कार्य में वन भूमि अपयोजन का प्रस्ताव(FP/BR/ROAD/154991/2022) इस कार्यालय को प्राप्त हुआ था। इस मामले में प्रासंगिक पत्र -1 के माध्यम से क्षेत्रीय कार्यालय, पर्यावरण, वन एवं जलवायु परिवर्तन मंत्रालय, भारत सरकार, राँची द्वारा क्षेत्रीय सशक्त समिति की 74 वीं बैठक की कार्यवाही के आलोक में प्रतिवेदन की मांग की गयी है।

इस संदर्भ में कथनीय है कि इस कार्यालय के पत्रांक- 921 दिनांक- 24.03.2025 के द्वारा विषयांकित परियोजना की जाँचोंपरान्त वन भूमि अपयोजन का प्रस्ताव निर्धारित प्रपत्र में Part-II में आवश्यक प्रविष्टि कर पाँच प्रतियों में अग्रेतर कार्रवाई हेतु भवदीय को समर्पित की गई है। क्षेत्रीय सशक्त समिति की 74 वीं बैठक की कार्यवाही के आलोक में प्रतिवेदन निम्नवत् समर्पित की जाती है:-

2	The reduced area is result of exclusion of high encroachment sections, bridge areas over some water bodies and few vegetation-rich roadside segments.	- Reply has been received from user agency as per their letter no. 41 dt. 30.01.2025 (Photocopy attached). According to this, "The KMZ has been as per the opinion of the committee and based on the directions of DFO, Mithila. Accordingly, the total forest area proposed for diversion now comes to 37.507 ha."
3	The Committee expressed its surprise over the remark by NHAI representative who informed the committee that after the contextual joint inspection, those areas (which are excluded from proposal) were found "non-notified land" and hence excluded from the proposal resulting into reduced area. The committee was of the opinion that usually an entire stretch of the roadside is notified as forest and particular spots or patches of the roads are not excluded from such notifications.	- The area details are attached as Annexure-I and alignment(s) are also shown line diagram as Annexure-II showing Forest & Non-Forest part of the stretches. - Entire stretch of the roadside has been taken into consideration irrespective of any encroachment present on the side
4	The concerned DFO, citing his new joining, requested the committee that he would again look into the matter personally to modify/correct the proposal according to the related notification order.	
5	Committee also observed that due to aforementioned exclusion, the total alignment of the road is missing from the proposal. Therefore, user agency must correct the KML so that it clearly depicts the total alignment of the road and forest as well as non-forest areas within it.	- Reply has been received from user agency as per their letter no. 41 dt. 30.01.2025 (Photocopy attached). According to this, "The KMZ has been revised as per the opinion of the committee and attached herewith. Also, the alignment details for the Forest & non-Forest part are enclosed as Annexure-II." - The total alignment of the road including Forest as well as non-forest areas has been shown in the KML File(attached)
6	Committee requested user agency to submit the diversion application correctly. It also requested state authorities-DFO and nodal officer present there, to carefully examine the applications submitted by user agencies and to ensure that technically faulty applications are not forwarded to regional office level.	- The revised proposal received from the user agency has been checked and no faults have been found as per my understanding. - KML file is showing the complete alignment of the road including forest and non-forest area of the project. - Area calculation sheet (37.507 ha) is attached with the proposal.

(v)	Legal status of forest	The proposed project area is passing through protected forest area of notified protected forest i.e., <u>Kaluahi to Umagaon in Madhubani Range, Rahika to Saharghat in Benipatti Range, and Bideshwarsthan to Bheja in Jhanjharpur Range</u> of Mithila forest division. It crosses tthe different stretches of notified roads in Madhubani, Benipatti and Jhanjharpur Range(mentioned in the Tree Enumeration list attached as Annexure-3). It requires diversion of the above mentioned notified roads for rehabilitation, upgradation and construction of two lane with paved shoulder of selected road stretches under abovementioned forest ranges in Mithila forest division. It is notified as Protected Forest by Environment and Forest department, Government of Bihar through Vide S. O. No. Notification No. 190-E dated 16.02.1994. Earlier, part - II hasd been written and sent vide letter no. 2114 dt. 19.10.2022 by the then DFO, Darbhanga. Again a joint inspection was done with the representative of NHAI. After this inspection, part-II was submitted to CF, Muzaffarpur by then DFO, Darbhanga vider letter no. 2205 dt. 21.11.2023. It was found that a certain portion of road for which the land diversion proposal has been made by the user agency is non-notified government land and this proposal requires diversion of 32.27 ha of protected forest land instead of 39.1096 ha as communicated by NHAI vide letter 462 dt. 08.11.2023. Thereafter, IRO Ranchi after perusal of the proposal directed to make necessary modifications in kml files of the proposal and submit the necessary supporting documents. Subsequently, a confirmation from user agency was sought on the area required for diversion. As communicated by user agency vide letter 41 dt. 30.01.2025, letter 87 dt. 27.02.2025 and as per field verification reports from range officers during field visit it was found that the proposed project requires <u>diversion of 37.507 Ha</u> of protected forest land. Hence 37.507 Ha of land is being submitted for diversion. (Notification annexed in Annexure-1 of Part-II Report)

The nearest natural forest boundary from the ranges in which the proposed site is situated is Valmiki Tiger Reserve, which is approximately 300 Km away.

This requirement of Forest land is unavoidable and is bare minimum required for the project. The land is almost flat and this land is not vulnerable to soil erosion. This land is not part of any National Park, Wildlife Sanctuary Biosphere Reserve, and Elephant Corridor etc. No rare/endangered/unique species of flora and fauna are reported to be found in the area. No archeological/heritage site/important monument was seen during the visit of the proposed site. Air Force Station, Darbhanga and Darbhanga Airport is located around 30-40 Km from this project area. Indo-Nepal border, Pipraun is situated at the distance of nearly 5 Km from Umgaon site of this project. Completion of this project will help in reducing traffic issues on the existing road and also reduce the travelling time of the commuters, therefore, the required land is recommended for diversion.

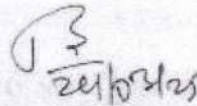
Site Inspection Report of Divisional Forest Officer

(For the forest land to be diverted under FCA 1980)

A Proposal has been received by this office from Deputy General Manager, Project Implementing Unit, NHAI, Supaul. The name of the project is Rehabilitation, upgradation and construction of 2 - lane with paved shoulder of selected road stretches Section-I : Umgaon to Kaluahi (0.000 - 21.610 Km - NH 227L), Section - II: Saharghat to Rahika(0.000 - 26.135 Km - NH227J), and Section - IV: Bideshwarsthan to Bheja (0.000 - 25.915 Km - NH527A) under Bharatmala Scheme in Madhubani District in the state of Bihar. The project aims to improve connectivity particularly on religious, backward and to remote areas with an aim of rapid and safe movement to boost economy. The execution of the project requires diversion (Under FCA-1980) of 37.507 ha of forest land for non-forestry purpose by NHAI, PIU-Supaul. The site inspection of the land involved in the proposal has been done by me on 17-03-2025. Few trees were inspected randomly and found to be correct.

The proposed project area is passing through protected forest area of notified protected forest in Jhanjharpur, Benipatti and Madhubani Range of Mithila Forest Division. It crosses various stretches of notified roads in three mentioned ranges as mentioned in tree enumeration list. These roads are notified as Protected Forest by Environment and Forest department, Government of Bihar through Vide S. O. No. Notification No. 190-E dated 16.02.1994. As per the tree list submitted by user agency after joint inspection with forest department officials, it has been reported that total of **3849** trees lie in the notified forest area segment of the proposed project area. A separate proposal for the trees located in the non-forest area will be submitted by the user agency for consideration of Regional Empowered Committee headed by RCCF, Muzaffarpur. Tree Protection plan of 3849 trees

This requirement of forest land is stated to be unavoidable and bare minimum required for the project. The land is almost flat and this land is not vulnerable to soil erosion. This land is not part of any National Park, Wildlife Sanctuary Biosphere Reserve, and Elephant Corridor etc. No rare/endangered/unique species of flora and fauna are reported to be found in the area. No archeological/heritage site/important monument was seen during the visit of the proposed site. Air Force Station, Darbhanga and Darbhanga Airport is located around 30-40 Km from this project area. Indo-Nepal border, Pipraun is situated at the distance of nearly 5 Km from Umgaon site of this project. Further, the user agency has not violated the provisions of Forest (Conservation) Act. 1980 and no work has been carried out by the user agency as per my knowledge.
