The State Govt. in the once agian requested to correct the information and if required do the proper justification for the poor progress of CA	Correct and Revised details of CA Stipulation against total forest area has been Filled in Coulum No.14 of part- II
5. In the DSS analysis it is found that 3.10 ha area is overlapping with the online proposal no FP/UK/Road/9775/2015. The State Govt. may replace this area with some other area suitable for CA and provide/upload revised digital map , SOI Toposheet map and KML File against after making the above change	The road project for which the proposal No. FP/UK/ROAD/9775/2015 (Sod Gajeli-Kagdi-Manglakoti-POkhri motor road in district Pauri) has been submitted has now been terminated by the department and proposal for lanad acquisition has been withdrawal accordingly. Hence there is no need of CA land for the mentioned proposal
