

Cumulative Impact Study of Beldenga Stone Mahal

The entire project area of 5.12 Ha of Beldenga Stone Mahal is forest land of Doboka R. F., and it is devoid of any valuable trees but covered with degraded mixed forest with grass & shrubs. There is no human settlement within 0.6 Km radius from the project area, hence no resettlement and rehabilitation is proposed. Nearest habitation is Changmazi Mikir Pather, which is about 3.02 Km towards west direction from the project area. The drainage pattern comprises of small streams carrying rainwater during rainy season. Presently, there are 4 numbers of approved Mining Areas and 2 numbers of under process proposals in nearby areas, the details of which are given in the table below.

The cumulative impact because of the operation of the Beldenga Stone Mahal can be given as follows (Based on the Environment Management Plan duly submitted by user agency to the State Environment Impact Assessment Authority for the purpose of granting Environment Clearance to the concerned project):

- **Impact on Atmosphere:** Air pollution due to excavation, line drilling, dressing, loading-transportation etc. However by using control measures like water sprinkling, wet drilling, tree plantation along mine boundary, the impact can be reduced.
- **Impact on Land:** Quarrying will alter the shape of the present hill slope and the quarry leased area will be reduced to some level from actual ground level. The proposed quarry will generate negligible quantities of overburden mainly as topsoil and waste rock fragments which will be used for reclamation in future. "Progressive Mine Closure Plan" will be implemented for the ecology of the area.
- **Impact on water bodies/ ground water:** No major water bodies in the area. The domestic wastewater generated from the quarry will be sent to the settling tank to arrest the silt and rock fragments produced due to mining activity. The proposed quarrying activities will not obstruct the ground water table.
- **Impact due to noise:** Noise produced from quarrying operations is not continuous and are mainly due to Drilling, Blasting, Dressing and Machinery operations. However by using control measures like use of low explosives and less quantity, green belt along mine boundary, the impact can be reduced.

The Beldenga Stone Mahal Project will be environmentally compatible to the surroundings due to the implementation of high standards of pollution control measures and Environment Management Plan to minimize adverse impacts on the environment.





The entire project area of 5.42 Ha of Lankaijuri Stone Mahal is forest land of Doboka R. F., and it is devoid of any valuable trees but covered with degraded mixed forest with grass & shrubs. There is no human settlement within a radius of 1.1 Km of the project area, hence no resettlement and rehabilitation is proposed. Nearest habitations are Bhagiram Gaon at a distance of 1.78 Km towards South-East direction and Modertoli Mikir gaon at a distance of 2.15 Km towards West-South direction. The drainage pattern comprises of small streams carrying rainwater during rainy season. Presently, there are 4 numbers of approved Mining Areas and 2 numbers of under process proposals in nearby areas, the details of which are given in the table below.
