Sub: Proposal for diversion of 3.305 ha falls within the area of 69.804 ha of 220KV S/c (2 Conductor) line Bonai to RTSS, Bimlagarh in Sundargarh District. (Proposal No. FP/OR/TRANS/33755/2018, State Sl. No. OR-019/2018 dated 13.04.2018)

Ref: Your Memo No.2207 Dtd.18.08.2020.

With reference to the above, the point wise compliance of the deficiencies in the above diversion is furnished below:

1. Nowhere in the Check lists, Form-A (Part-I) and Site Inspection Report, date & place have been given. Further, the Form of Check list Sl. No.18 has neither been filled up nor the same has been signed by the DFO, Rourkela Division. Part-II of the Check list at Page No.4 has not been filled up with required information/data.

2. The District Profile has not been submitted in the diversion proposal.

District profile has been enclosed in the diversion proposal.

3. The total area (both forest & non-forest) involved in the project is 69.804 ha., but it has been mentioned to be 69.754 ha at Page.11/DP. The discrepancy needs to be rectified.

Necessary rectification has been done and correct area is 69.804ha.

4. In the Site Inspection Report, it has been mentioned that out of 227 Nos. of trees enumerated over the forest land, 140 Nos. is required to be the felled and the rest will be pruned. But in the Part-II/DP, it has been mentioned that out of 726 Nos. trees enumerated both in forest and Non-forest land involved in the project, 140 nos. is required to be felled and the rest will be pruned. Further, in the forwarding Letter sent vide your Memo No.4484 Dtd.10.08.2020, under Para-4 i.e. "Tree Enumeration", it has been mentioned that, total enumeration has been carried out over applied area and 726 nos. of trees have been enumerated above 30 cm girth and all the enumerated trees may require to be felled during the commencement of works. The discrepancies and contradiction in the statement may be clarified.

Total enumeration has been done over applied area of 69.804 ha (in both Forest and Non-Forest) and 726 nos. of trees (i.e 227 +499) have been enumerated above 30 cm girth ,out of which, 140 nos. of trees may require to be felled from Forest land. Rest enumerated trees may not require to be felled during the commencement of works.

5. In your Site Inspection Report, against Sl.No.4, i.e. Name & designation of the Officer who attended the inspection, it has been mentioned as Sanjay Jumar Swain, IFS. It needs to be corrected.

Name & designation of the Officer (DFO) has been corrected in site inspection report.

6. The Forest area proposed for diversion in respect of the above project is 3.305 ha. Therefore, it being laying of transmission line project, CA shall have to be raised and maintained at the cost of the User Agency on degraded forest land twice in the extent of the forest area proposed for diversion as per clarification under Para 2.5(i) of the hand book of F.C. Act, 1980.

Further, as reported by you the forest area proposed for diversion in the instant proposal is 3.305 ha, the nos. of seedlings required to be planted would be as per Para 2.8(i) of the hand book of F.C. Act, 1980.

But in the instant case, the CA scheme has been prepared over 17 ha of degraded forest land identified in Kukia RF of Banki Range under Rourkela Division with proposal therein for planting 6800 Nos. of seedlings. The justification for identifying more degraded area for CA with proposal therein for planting more nos. of seedlings needs to be given.

Plantation to be done in the identified degraded forest land over 6.610 ha i.e twice in the extend of proposed area. But, gross area of Degraded Forest land has been identified over 17.0 ha and as per suitability, 400 nos. plants/ha, to be planted within the net area to accommodate the total seedlings. Accordingly, Compensatory Afforestation scheme has been prepared.

7. As per instruction of the PCCF(FD & NO, FC Act),O/o the PCCF, Odisha vide his Memo No.13318 Dtd.13.07.2020 & this office Memo No.1755⁽⁵⁾ Dtd.13.07.2020, you have to submit 4(four) sets of diversion proposal duly filled in Part-II along with its pdf. file also in 4(four) sets.

8. The Land schedule of the Forest land has not been countersigned by the DFO, Rourkela. Further, the User Agency has not signed at some of pages of Land schedule.

9. **In the forwarding letter under Para-8 i.e. "Certificate under FRA, 2006", it has been mentioned that, the user agency has submitted an undertaking regarding submission of Certificate under Forest Right Act, 2006 as soon as it is received from the District Collector, Sundargarh. But at Page-28/DP, a Certificate under FRA, 2006 issued by the District Collector, Sundargarh over 3.305 ha. of forest land has been enclosed. The same may be clarified.**

Certificate under FRA, 2006, issued from Collector, Sundargarh is hereby enclosed in DP.
