Subj: Show Cause Notice for Violation of The Mizoram (Forest) Act, 1955.

Sir,

With reference to the subject cited above, the undersigned is to serve show cause notice to you in discharge of her duty as Divisional Forest Officer, Mamit Forest Division as follows:

It is observed that clearing and damage of forest area of 0.4 ha had been undertaken for the project proposal for diversion of 11.17 ha of forest land for construction of 132 Kv line between Bairabi to W.Phaileng via Mamit Transmission line inside Tut- Langkaih Protected Council Reserved Forest and Teirei and Tlawng Riverined Reserve Forests which are the recorded Reserved Forests declared under The Mizoram (Forest) Act, 1955 vide Assam Gazette Notification dated 19th May, 1965 and Vide Notification No. 1 of 1970 dt. 24th June, 1970.

The Mizoram (Forest) Act, 1955 Section 24 prohibits any person who in the Government Reserved Forest (3) fells, cuts, girdles marks, lops, taps or injures by fire or otherwise any trees, or (4) quarries stones, burns lime or charcoal or collects subject to any manufacturing process or removes any forest produce, or (5) clears or breaks up any land for cultivation or any other purpose or in contravention of any rule made by the State Government shall be punished with imprisonment for a term which may extend to six months or with fine which may extend to five hundred rupees or with both.

The Forest (Conservation) Act, 1980 as well as orders of the Hon'ble Supreme Court banned taking up of any non forest activity on forest area without prior approval of the Central Government under the Forest (Conservation) Act, 1980. Section 2 of the Forest (Conservation) Act, 1980 imposes restriction on de-reservation of forest area and use of forest area for non-forest purpose as follows:

"Notwithstanding anything contained in any other law for the time being in force in a State, no State Government or other authority shall make, except with the prior approval of the Central Government, any order directing-

- (i) *that any reserved forest (within the meaning of expression "reserved forest" in any law for the time being in force in that State) or any portion thereof, shall cease to reserved;*

- (ii) that any forest or any portion thereof may be used for any non-forest purpose ;
- (iii) that any forest land or any portion thereof may be assigned by way of lease or otherwise to any private person or to any authority, corporation, agency or any other organization not owned, managed or controlled by Government;

For the purpose of the above section, the terms "Forest" and "Forest land" have been defined by the Hon'ble Supreme Court of India in the landmark order on 12.12.1996 in W.P(C) 202/1995 read with W.P(C) No.171/1996 as follows :-


The word "forest" must be understood according to its dictionary meaning. This description covers all statutorily recognized forests, whether designated as reserved, protected or otherwise for the purpose of Section 2 of the Forest Conservation Act.

The term "forest land", occurring in Section 2, will not only include "forest" as understood in the dictionary sense, but also any area recorded as forest in the Government record irrespective of the ownership. This is how it has to be understood for the purpose of Section 2 of the Act. The provisions enacted in the Forest (Conservation) Act, 1980 for the conservation of forests and the matters connected therewith must apply clearly to all forests so understood irrespective of the ownership or classification thereof. Para 1 of the same order clearly says that prior approval of the Central Government is required for any non-forestry activity within the area of any forest and in accordance with section 2 of the Act, all on-going activities within any forest in any State throughout the country without prior approval of the Central Government, must cease forthwith.

In view of the above, it is obvious that the provisions stated above have been violated as you had undertaken activities inside the above mentioned Reserved Forest areas without prior permission and clearance from the Competent Authority.

You are hereby informed to explain as and why such activities had been undertaken in violation of The Mizoram (Forest) Act, 1955. Your reply must reach this office within 10 days after date of receipt of this notice, failing which it shall be construed that you have nothing to say in this regard and necessary action shall be initiated against you without further notice.


With reference to the above, I have the honor to clarify as below in reply of the Show Cause Notice for Violation of The Mizoram (Forest) Act, 1955:

1. In order to improve Power Distribution system in the Western Region i.e Mamit District, Detail project '**Construction of 132kV Line Single Circuit Line on Double Circuit Tower from Bairabi to West Phaileng via Mamit**' incorporating No Objection Certificate regarding Forest Clearance issued by the Competant Authority of your Deptt even vide no B.23013/63/2014-FC/PCCF/153 Dt 23.March.2015 was submitted to North Eastern Council Shillong for acceptance and sanctioned. The Copy of No Objection Certificate issued by competent Authority is enclosed herewith. Accordingly, North Eastern Council Shillong had approved the Detail Project and fund was release vide NEC/POW/577/MIZO/2014-15/5867 Dt 19.4.2017
2. As soon as the Project was accepted by the competent Authority and to complete the work within target period Work was started on war footing basis since in the year 2017.
3. In course of execution of the 132kV Line you had relaised that some locations of 132kV Towers alignment falls within Forest Reserve Area, as such you had cancelled NOC and issued Stay Order accordingly.
4. As NOC was cancelled Forest Clearance had been applied by this Deptt and uploaded @ parivesh.nic.in which is under process.
5. After receiving Stay order and cancellation of No Objection Certificate '**no new activities was executed by this Deptt till date inside your Forest Reserve Area**'.

6. While executing the Construction line, if any violation of any section of The Mizoram (Forest) Act, 1955, had been observed by you, for which we are ready to bear any fine thereof and it is felt deeply regretted and appologised for the same and shall not be repeated in due course.

This is for favor of your kind information with a request to accept and seeking your kind cooperation for the success of the project.
