Proposal for diversion of 3.305 ha Revenue Forest Land under Forest (Conservation) Act, 1980 for construction of 220KV S/S Power Transmission line from GSS, Bonai to RTSS, Bimalagarh by OPTCL Proposal No. FP/OR/TRANS/33755/2018 dt.28.03.2019 with State Sl. No. OR-030/2018 dated 29.05.2018)

With reference to your memo on the captioned subject cited above, the compliance of the deficiencies noticed by PCCF, Forest Diversion & Nodal Officer, F.C. Act., Bhubaneswar is furnished below for favour of your kind information and necessary action.

- 1. Study ing the KML file of identified CA land of 17 ha in Kukia RF of Banki Range enclosed with the proposal under DSS of FSI portal it is seen that the area falls in Sambalpur District.(DSS report enclose as Sheet-1)**

The KML file of other Diversion Proposal had been submitted wrongly with this Diversion Proposal. Now the accurate/ corrected KML file for the diversion proposal of construction of 220KV S/S Power Transmission line from GSS, Bonai to RTSS, Bimalagarh by OPTCL, is submitted, which will be tally with the CA land of 17ha. in Kokia RF of Banki Range. The in convenience caused at your end is regretted.

- 2. Carving out the identified CA land using the GPS coordinates of the boundary pillars of the identified CA land furnished by you on the Topo sheet Map(Topo sheet no F45M13) of identified CA land using DSS of FSI portal, it is seen the land comprises of 12 ha of MDF & 5 Ha of Open Forest.(DSS report enclosed as Sheet-2)**

Plantation is to done over 6.610 ha i.e. twice in the extent of proposed area. But, gross area of Degraded Forest land has been identified over 17.0 ha and as per suitability, 400 nos. of plants/ha can be planted within the net area to accommodate the requisite nos. of seedlings. This is to mention here that, out of 17 ha of forest(gross area), 5 ha comes under open forest. So the required numbers of seedlings can be easily accommodated.

3. The CA scheme envisages plantation in ANR mode with 400 plants/ha over 17 ha which is not compatible with the crop position as visualized from DSS report at Sheet-2.

As per diversion proposal, 6.610 ha (3.305 x 2 = 6.610) degraded forest land is required for Compensatory Afforestation. But, the plantation will be taken up over 6.610 ha, out of the gross area over 17.0 ha in Kukia RF to accommodate the requisite nos. of seedlings. Out of the gross area of 17 ha as much as 5 ha comes under open forest.
