Kerala Water Authority Perumbavoor Project Director had submitted a proposal in Parivesh portal (FP/KL/Pipe line/41944/2019) for the augmentation of water supply scheme in Angamaly Constituency. The requested area for the above work under this division was 1.09952 Ha and my predecessor had recommended for the conversion of 0.77238 Ha of forest land.
