1. Lease for 899.53 acres Reserved Forest land was granted to IDPL by the then U.P. government vide G.O. number 4914/14 A -132-1950 dated 12-12-1969 for a period of 60 (30+30) years starting from the year 1961. The lease has expired on 27.11.2021.
2. Out of 899.53 acre of Reserved Forest land as aforesaid 65.652 acres of land was taken back by the Forest Department out of which 0.372 acres of land was transferred to the Post and Telegraph Department of the Government of India for the construction of Post office building and staff quarters and 65.28 acres of land was transferred to the Uttar Pradesh State Electricity Board for the construction of Electric Station on 16th February, 1978 and November 1972 respectively.
