2. The pointwise reply of the shortcomings/observations is reported as under:-

1. Revised geo-referenced digital map alongwith geo-coordinates of all the components has been uploaded at Para C (iv) Part-I online and hard copy is enclosed herewith.
2. Revised KML file for the area proposed for diversion showing all the components of the project has been uploaded online at para C (ii) Part-1 and soft copy is enclosed herewith.
3. The detail of employment likely to be generated during the construction of project has now been uploaded at para-E Part-I online.
4. User agency has submitted that actually the project is proposed to be established at village Bithri. This village Bithri covers under Muhal Kuthachi as well as Gram Panchayat Kuthachi, which creates the confusion.
5. Justification of the project location on forest land duly authenticated by DFO has now been uploaded online at para D (i) Part-I and hard copy is enclosed herewith.
6. The extent of area for CA (0.58 ha) mentioned at para-13 (i) of Part-II has now been deleted online.
7. The data filled at para M (ii) of Part-I has now been deleted online.
8. User agency has intimated that the case shown as linear project at para A-1 (vi) has now been corrected to be non linear.

9. User agency has reported that during the DPR was drafted and while taking the area on finalization, it was felt that there is no need of building shown at page No. 46. So the information as uploaded at Para-B 2.4 online is correct and treat it as final.

It is, therefore requested that necessary stage-I approval to the proposal may kindly be accorded in favour of user agency at the earliest please.
