The proposed area does not require any trees to be removed since there are no trees in the 0.009 Ha land

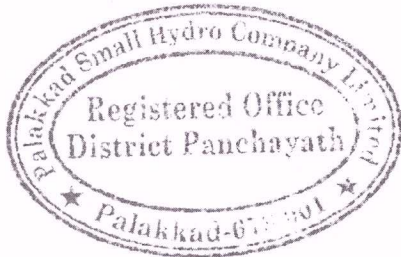
