

The ADM&G, Tadipatri submitted that, as seen pit measurements the excavated Mineral quantity is Steatite 15813@2.5=39532 MT, Dolomite 1976@2.5=4940, MT, and Steatite (LG) 988@2.5=2470 MT and as per dispatch permits the lease holder has taken the dispatch permits for the quantity of 39720 MT of Steatite (H.G) and 250 MT of Dolomite, and as per the dispatch quantity and as per the available quantity at the mine site which are more or equal to the excavated quantity.

The ADM&G, Tadipatri submitted that, the lessee company has submitted that Income Tax returns for the last 3 years i,e 2017-18, 2018-19 & 2019-20. And also submitted Net Worth Certificate in worth of Rs, 5,82,15,635/- the same copies are enclosed here with for kind perusal.

The Minerals Steatite & Dolomite were hitherto Major Minerals till 09.02.2015 and the GoI vide G.S.R.No.423 (E), dt:10.02.2015 declared 31 Major Minerals which includes Steatite & Dolomite, as Minor Minerals. The State Government vide G.O.Ms.No.34, dt: 14.03.2016 delegated the powers of granting Leases to the Director of Mines & Geology in respect of these 31 minerals and vide G.O.Ms.No. 56, Dt: 30.04.2016 made amendments to the APMMC Rules, 1966 for regulation of these 31 minerals.

Accordingly, the applicant Sri Sai Minerals has obtained Approved Mining Plan, Environmental Clearance, Consent for Establishment and Consent for operation.

On perusal of the documents submitted by the applicant through the ADM&G, Tadipatri the lessee is holding all the statutory clearances which includes Permission accorded vide G.O Ms No.20 Environment, Forest, Science & Technology (For.I) Department, Dt: 01.03.2013 valid upto 09.06.2022, Mining Scheme approved by the Deputy Director of Mines & Geology, Kurnool vide Lr. No: 1206/MS-TDP/2019, dt: 27.06.2019 valid up to 2022-2023, Environmental Clearance issued by the SEIAA of AP, MoEF vide Order No: SEIAA/AP/ATP-58/2013-4499, dt: 23-10-2013 for a quantity of 1031 TPA of Dolomite and 2498 TPA of Steatite, Consent of Establishment (CFE) issued by the Joint Chief Environmental Engineer, Kurnool vide order No: ATP-52/APPCB/ZO-KNL/CFO/2017-479 dt: 23.07.2002 valid for a period of 5 years from the date of issue, Consent Order for Operation vide Order No: ATP-52/APPCB/ZO-KNL/CFO/2017-565, dt: 23-08-2017 valid upto 30-09-2022, possession for use of Explosives from Magazine issued by the Deputy Chief Controller of Explosives, Visakhapatnam vide No: E/SC/AP/22/808(E28534), dt: 18-04-2019 and valid upto 31-03-2024 and Copy of Authorization to Srf Mooli Sreedhar Reddy to work as Manager over the subject mine vide No: BLR-AN-UG/Dol & Ste.-27/P-34(6)/2020/1536, dt: 17.07.2020 issued by the Directorate General of Mines Safety, Bellary.

Further, the ADM&G, Tadipatri informed that the lessee is working with in the leased area, further the applicant has stated that, he has developed and laid roads to the Quarry with his own cost and he is having own machinery for transportation of raw Material and finished mineral. Further the lease holder has informed that, he has given Rs. 15.00 lakhs towards advances to the laborers for retention.
