3.	Examination of kml/shape file of land proposed for Compensatory Afforestation shows 17 ha. of land (out of total area) falling in River and same is also depicted through Googal earth imagery. The State Government may kindly provide the suitable (17ha.) CA land and submit the revised. kml/shape file of the total area proposed for CA.	17 ha area out of the total CA areas is not falling in the river, The area is near The river, during heavy rains some water passes through the ravines. So the plants which are suitable for ravines and can withstand water inundation for some time will be planted in that 17 ha area.
4.	Site suitability of proposed compensatory afforestation site viewing proximity with river and located in flood plains may also be ascertained.	Site selected for CA is in proximity with the river 17 ha area where there are chances of water during heavy rains, plants which are suitable like Acacia nilotica will be planted in that area.

3.	Examination of kml/shape file of land proposed for Compensatory Afforestation shows 17 ha. of land (out of total area) falling in River and same is also depicted through Googal earth imagery. The State Government may kindly provide the suitable (17ha.) CA land and submit the revised. kml/shape file of the total area proposed for CA.	Some parts (17 ha.) of Proposed CA land falling inside the revenue land which is adjoining with the river. During monsoon season, the area was full of water for which plantation of this land is not possible. Hence The amount for balance plant (not planted on Proposed CA land) will be paid. Undertaking for this purpose is enclosed.
4.	Site suitability of proposed compensatory afforestation site viewing proximity with river and located in flood plains may also be ascertained.	Not related with User Agency
