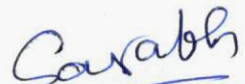

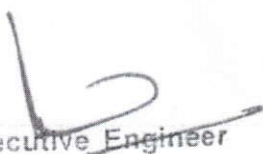

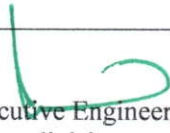

Project details:-

The forest land is required for the Construction of link road from Gulriya Dhang to Nero Kotri km. 0/0 to 4/935 to be constructed by H.P.P.W.D. division Nahan. Total length of the road is 4.935 kms, the road alignment passes through forest land and private land.

The total length of proposed alignment is 4.935 kms with average width of 6.00 meter. The road alignment passes through forest and private land. The portion from km. 0/0 to 0/120, 0/585 to 2/945, 3/015 to 3/795 & 4/135 to 4/500 will be passes through forest land and portion from km. 0/120 to 0/585, 2/945 to 3/015, 3/795 to 4/135 & 4/500 to 4/935 will passes through private land. Excavated earth will be dumped on valley side of proposed road at RD. 0/0 to 0/060 in forest land which includes 0.18 Ha. Area of forest land and RD. 0/200 to 0/260, 0/350 to 0/410 & 3/800 to 3/800 to 3/860, having area of 0.54 Hac. Private land on proposed road site. Hence total forest land of **2.355 hectare** including 1 number dumping site will be required for construction of this project in forest land. The private land of **1.326 hectare** i/c 3 nos dumping will be required for the road project.

The use of forest land is unavoidable since the settlements of the villages to be connected are situated on both sides of forest strip. The alignment selected for this road is shortest and involved less number of trees.

The village Neron Kotri is a Revenue village and situated about 15.00 kms away from the district Headquarter i.e. Nahan and situated in the interior part of district about 15.00 kms away from Nahan town. The road will take Burma papari road at RD. 7.120.

The Govt. of India has framed a policy to provide the road connectivity to all the villages having habitation more than 150 souls. These settlements of village nero kotri are also one of the villages having population more than 150 souls, hence it has to be connected with the road facility as per policy of the Govt. Of India. This road benefits the Villages of Guleria Dhang, Neron & kotri having the population of approximate 596 souls. With the construction of this road, the economic status of the villagers of the connecting villages will be improved considerably.

The area has also a great Potential for Animal Husbandry Produces. At present not much people bring, their produces for marketing for want of transport facility. Therefore, the road on its completion will enable the people to make maximum use of this vital factor of economy. With the construction if this road, the economic status of the villagers of the connecting villages will be improved considerably. The Horticulture and Agriculture produce such as, Garlic, Ginger, Chilli and pulse etc are grown in the area and people faces lot of problems in marketing the above cash crops for want of the road, the other services like Health, Education and other development activities will also be improved with the construction of this road. The people shall gain employment during the construction activities and thus shall be helpful in ameliorating the poor economy of the area.

Cost of Project and employment generation .

The total estimate cost of the project is to be the tune of Rs. 181.96 lacs and approximate 18000 man days will be generated during the course of execution which directly and indirectly give the benefits to the local people.

Environmental detail:-

The ill effect on the environment, which is anticipated with the construction of road has been taken care off. The net executed quantity of muck to be generated 47850 and 20934 cum shall be disposed in dumping sites. The area of dumping site is 7200 sqmt having capacity of muck 24795 cum. 4 Nos dumping sites has been proposed in forest area. The proper plan has been made to minimize the soil erosion in the

catchment by providing the proper drainage and soil conservation measures. The compensatory afforestation shall also be carried out to compensate for the loss of forest land to be used for construction of road. Thus every care has been taken to minimize the ill effect on the environment.

Plantation.

The alignment was seen with view to minimize the involvement of forest land and also to minimize the adverse environment affect due the construction of road.

Out of two alignments, alignment No 1 has been found suitable whereas alignment No. 2 as shown in map have been rejected on the following grounds.

Alignment No. 2

The length of alignment no. 2 is 5.00 kms and its gradient is very steep at some locations. It involves more forest area, more trees as compared to alignment No. 1 Hence alignment No.2 is rejected.

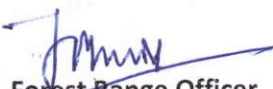
The alignment No. 1 passes through reserve forest compartment No.C1, R.F. Mahidhar, C5, C6 of R.F. Bhudpur Kotla of Trilokpur Range., Nahan Block. The total length of proposed alignment is 4.935 kms with average width of 6.00 meter. The road alignment passes through forest and private land. The portion from km. 0/0 to 0/120, 0/585 to 2/945, 3/015 to 3/795 & 4/135 to 4/500 will be passes through forest land and portion from km. 0/120 to 0/585, 2/945 to 3/015, 3/795 to 4/135 & 4/500 to 4/935 will passes through private land. Excavated earth will be dumped on valley side of proposed road at RD. 0/0 to 0/060 in forest land which includes 0.18 Ha. 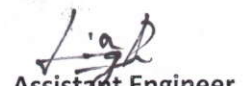

The involvement of forest land is unavoidable as whatever the alternative alignment is feasible that passes through forest land, thus, making it inescapable to involve forest land.

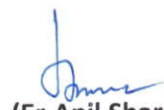
