Kindly refer to Integrated Regional Office, MoEF & CC , CGO Complex Longwood Shimla file No. FC/HPB/01/74/2021 dated: 02.09.2022 on the above cited subject.

The pointwise reply of observations raised vide above referred communication has been attended by DFO J/Nagar , submitted as under:-

1. The comments of CWLW has been uploaded in PARIVESH portal as additional information in Part-II.
2. The copy of letter of Superintending Engineer. (OP) Circle HPSEBL, Mandi alongwith diagram has been uploaded in PARIVESH portal as additional information in Part-II.
3. The user agency has intimated that the issue measurement in KARAM in Mandi Distt. is already under consideration at MoEF & CC level. It will take time to adopt universally accepted system of land measurement possibly in Mtrs as unit measurement.
4. The user agency has intimated that Para A-2 of Part-I is not editable.
5. The approved letter of HIMURJA for change of name from M/s Bhup Raj to M/s Shivganga HEP has been uploaded in PARIVESH portal as additional information in Part-II.
6. i) The status of proposed CA land is OD-152, DPF Dibkan. It is notified as DPF under IFA, 1927, as it is old Demarcated Protected Forests as per Mandi/Jogindernagar Working Plan and is in possession of HP State Forest Department and the copy of same has been uploaded in PARIVESH portal as additional information in Part-II.  
ii) The proposed site of CA has been checked by the concerned field functionaries and verified that the forest land is in the open forest land category covered with lantana, bushes etc. and scattered trees and is fit for compensatory afforestation.

It is, therefore, requested that keeping in view of above facts necessary approval of the proposal under FCA, 1980 may kindly be obtained and conveyed to this office please.
