

Kindly refer to the observations raised by Govt. of India, Sub-Office Shimla (Regional Office, Chandigarh), Ministry of Environment, Forest and Climate Change, CGO Complex, Shivalik Khand, Longwood, Shimla, Himachal Pradesh -171001 vide letter No. FC/HPB/09/05/2024 dated 03.01.2025 on the subject cited above. In this regard the Point wise reply to the observations is as under :

Sr. No.	EDS / Observation	Reply
1.	In reference of the observation No. 5, REPLY IS NOT ACCEPTED, observation regarding the approach access to degree college was sought from State Govt., in reference to this State Govt. submitted that the College Campus has been proposed adjoining to the Mubarikpur - Dehra Kangra Highway, so there is no requirement of the road component. In this regard, NOC from HPPWD/NHAI is required to be submitted, duly authenticated by competent authority.	The NOC from the HPPWD and National Highway Division HPPWD has been uploaded against Additional Information Detail. However, now the Mubarikpur-Ranital - NagrotaBagwan Highway has been handed over to the NHAI. The proposal for "Grant of Access Permission" has been submitted to Project Director NHAI, PIU Hamirpur and will be submitted before applying for Stage II Approval of the Proposal. An Undertaking in this regard has been uploaded against Additional Information Detail by User agency & has requested to kindly consider the Proposal for Stage I Approval.
2.	In reference of the observation No. 7, REPLY IS NOT ACCEPTED, revised layout plan showing all the components was sought from State Govt. In reference to this State Govt. has submitted the detailed layout plan. It is found that, there is hostel block proposed in the layout however same is not included in the Component wise breakup B-2.4. State Govt. shall clarify the same and update the components wise breakup in Part-I and with other documents uploaded in the PARIVESH.	The hostel block proposed in the layout has been included in the Component wise breakup B-2.4. The Revised Documents have been uploaded online in Part I by User agency.

3.	In reference of the observation No. 10, REPLY IS NOT ACCEPTED, details of purpose wise and component wise Khasra No. for all the components was sought from the State Govt. However same is not found uploaded at the PARIVESH. State Govt. shall upload the same duly authenticated by DFO concerned.	The details of purpose wise and component wise Khasra No. for all the components in forest land has been uploaded against the Additional Information Detail in online Part I by user agency. The College Campus has been proposed in Khasra No. 188/1 in Mohal Barwara, Tehsil Dehra, District Kangra (H.P.).
4.	In reference of the observation No. 13, REPLY IS NOT ACCEPTED, certificate of non-availability of NFL as per format in SCHEDULE -III from ChiefSecretary was sought from State Govt. However, same is not found uploaded at PARIVESH. State Govt. shall upload the same before Stage-I approval.	The certificate of non-availability of NFL as per format in SCHEDULE -III from Chief Secretary has been uploaded against Additional Information Detail in Part I by user agency.
