I submit that, the shortcomings noticed by the Principal Chief Conservator of Forests, Chennai in the reference 1st cited is rectified and the Compensatory Afforestation scheme cost estimate is revised based on the model cost estimate communicated by the Principal Chief Conservator of Forests, Chennai. Ref.No.TS4/22483/2022 dated.13.10.2022.

- 2) The Cost for raising Compensatory Afforestation scheme is prepared based on the current 2022-2023 FSR rate communicated by the Conservator of Forests, Dharmapuri Circle and also the work cost estimate for chain link fencing work based on 2022-2023 year rate is arrived and furnished.
- 3) I also state that, the naturally grown trees are existing in the identified Compensatory Afforestation land at SF.No.692/4 of kammampatti village and looks like a forest. Due to lack of possibilities to plant the 5000nos of targeted saplings in

this place, it is decided to plant the remaining 2000nos of saplings in the degraded Forest area of PARIGAM B Reserved Forest in Dharmapuri Range.

4) The adoption of chain link fencing and engaging the protection mazdoor for three years is only for identified Compensatory Afforestation land at SF.No.692/4 of kammampatti village and the degraded Forest land is manageable by Dharmapuri range front line staffs. Hence, this may be accepted.

Therefore, under these circumstances, i request that the proposal for diversion of 2.50 hectare of Forest land in Parigam-B Reserved Forest of Dharmapuri Range in Dharmapuri Forest Division for formation of road from Barigam Konayankadu to Malayurkadu may kindly be submitted to the Principal Chief Conservator of Forests, Chennai for getting the concurrence of the Government of India.
