Sub: Diversion of 0.918 ha. of forest land in Sy.No. 121 of Subramanya village, Sullia Taluk, Dakshina Kannada (Mangaluru) for establishing 1.5 MVA, 33/11KV Substation in Subramanya in favour of the Executive Engineer (Ele), O & M Division, MESCOM, Puttur, Dakshina Kannada District - reg. **Proposal. No. FP/KA/TRANS/8118/2014**

Government of India vide letter dated 12-02-2018 (ref-1) has sought clarification about the purpose of diversion of forest land and also reminded vide letter dated 24-09-2018 in this regard.

In response, the Chief Conservator of Forests, Mangaluru Circle vide letter dated 21-02-2019 (ref-2) has clarified that the diversion of 0.918 ha of forest land is for "**construction of 33KV line from Kadaba to Subramanya**" through Kidu Reserved Forest which will connect to 1.5 MVA Substation at Subramanya.

Therefore, it is requested that the same may be brought to the notice of the Government of India for further processing of the proposal.
