

Note on progress of processing of Ujh Multipurpose Project case in Parivesh Portal

The users agency has been requested to modify and update their proposal in **FORM-A (PART I)** in **Parivesh Portal** on the following issues;

1. **A. General Details.**
 - a. Change in forest area required for diversion from 1100 ha to 680.1 ha. In point (viii) under A-1 Project Details.
2. **B. Details of land required for the project.**
 - a. Change in the corresponding Component wise, Village wise, Division wise, District wise details of forest and non-forest area required in all the tables of B-2 (B-2.1, B-2.2, B-2.3 and B-2.4).
3. **C. Maps of Forest land proposed to be diverted.**
 - a. Corresponding changes as above in the divisions to be made.
4. **G. Details of Cost-Benefit analysis for the Project.**
 - a. To be provided in the prescribed format.
5. **L. Details of land identified for Compensatory Afforestation.**
 - i. Entry of 'Yes' to be made in point no (i) and corresponding details of the Non-forest land Compensatory Afforestation (CA) patches to be uploaded online.

The Divisional Forest Officers are preparing the CA proposal and uploading in the Parivesh portal. The CA proposals will be forwarded offline to competent authority for approval.
