
3. The Penal Compensatory Afforestation (PCA) over an extent of 11.24 Ha has
been raised on twice the degraded forest land in Palamalai and Pannikaradu Reserved
Forests of Salem Division during 2012-13 to a tune of Rs 3.091 Lakhs as per the
stipulated condition in Stage II Approval issued by the Government of India.

4. The Safety Zone Afforestation (SZA) has been raised over an extent of 2.50 Ha in Konur Reserved Forests of Mettur Range during 2013-14 to a tune of Rs 0.75 Lakhs as per the stipulated condition in Stage II Approval issued by the Government of India.

In exercise of the powers conferred by section 4 of the Tamil Nadu Forest Act, 1882 (Tamil Nadu Act V of 1882), the Governor of Tamil Nadu hereby declares that it is proposed to constitute the land the situation and limits of which are specified in the schedule below as a reserved forest and appoints the Thasildar, (Forest Settlement), Attur to be the Forest Settlement Officer, to exercise the powers under clause(c) of the said section.

BOUNDARIES

North.- The boundary starting the tri-junction point of Survey Field Numbers 71, 744/1 of Number 6, Alamarathupatti Village and eastern boundary of existing Pachapalamalai Reserved Forest, the boundary runs generally towards east along the southern

boundary of Survey Field Numbers 71 and 72 till it reaches of junction point Survey Field Numbers 743/2, 72, 73 and 743/3 of all Number 6, Alamarathupatti Village.

East.- Thence, the boundary turns generally towards south and runs along the western boundary of Survey Field Number 743/3 of Number 6 Alamarathupatti village and reaches the tri-junction point of Survey Field Numbers 743/2, 743/3 and 746, then runs generally towards western side along the northern boundary of Survey Field Number 746 and runs towards southern side along the western boundary of Survey Field Numbers 746 and 745/2 of same village and reaches the tri-junction point of Survey Field Numbers 745, 745/1A and 745/2 of the same village.

South - Thence, the boundary turns generally towards west and runs along the southern boundary of Survey Field Number 745 of same village and reaches the tri-junction point of Survey Field Numbers 745/1A, 745 of same village and Pachapalamalai Reserved Forest boundary.

West .- Thence, the boundary turns generally towards north and runs along the eastern boundary of Pachapalamalai Reserved Forest till it reaches the starting point.

NOTIFICATION-II.

BOUNDARIES.

North - The boundary starting the junction of No.138, Chinnakalarayan Therkkunadu Village Survey Number.2/2, 2/1 and Ammapalayam reserved forest (Notified under section 16 of Tamil Nadu Forest Act, 1882 vide in No.325 in Part-I of Fort Saint George Gazette, dated 21.7.1891 the boundary runs generally towards east (89.60 + 51.40 mt.) along the southern boundary of Survey Field Number.2/1 and thence towards north-east, south-east and again north east (32.40+31.60+20.00 mts.) along the southern boundary of Survey Number.3 till it reaches of the trijunction point Survey Number.3, 4/1 and 4/2 of all of 138, Chinnakalarayan Therkkunadu Village.

East - Thence, the boundary turns generally towards south (28.60 + 33.80 mts.) and runs along the western boundary of Survey Field Number.4/1 of Chinnakalarayan

Therkkunadu village thence turns towards south west (73.00 + 6.60 + 16.20 mts) and runs along the western boundary of Survey Field Number.22/4 of the same village and reaches the trijunction point of Survey Field Number.4/2, 22/4 and Ammapalayam Reserved Forest D stone all of 138 Chinnakalarayan Therkkunadu village.

South - Thence, the boundary turns generally towards western side (7.20+8.00+20.00+48.20+22.60+34.20mts) and runs along the northern boundary of Ammapalayam Reserved Forest (Notified vide Tamil Nadu Forest Act, 1882 in No.325 in part-2 of Fort Saint George Gazette dated 21.7.1891) and thence runs western side (50.60+48.40) along the northern boundary of Survey Number.2/3 hillock) of the same village and reaches the trijunction point of Survey Field Number.2/2, 2/3 and Ammapalayam reserved forest all of the 138, Chinnakalarayan Therkkunadu village.

West - Thence, the boundary turns generally towards northern side (84.40 mts. along the eastern boundary of Ammapalayam reserved forest and till it reaches the starting point.
