Kindly refer to your office letter FC/HPB/01/74/2021 dated 04.07.2025 on the subject cited proposal.

2. In this regard, it is submitted that the subject cited proposal was listed for discussion in the 7th REC meeting held on 30.06.2025. The matter was discussed based on the compliance report dated 02.05.2025, and the committee took the following decision:

"After detailed deliberations (in the REC held on 30.06.2025), the REC deferred the proposal and direct the User Agency to withdraw the proposal from PARIVESH 1.0 and upload the fresh proposal with new user agency name M/s Shiv Ganga Hydel Power on PARIVESH 2.0"

3. CF Mandi has intimated that, keeping in view the probable multiple complexities likely to be encountered in uploading the diversion proposal in PARIVESH 2.0 at this late stage, the project proponent, vide his application dated 21.07.2025 (copy enclosed, which is self-explanatory), has requested to remain and process the proposal in the PARIVESH 1.0 portal only. The proponent has also requested consideration for processing the proposal in the name **Dhanwan Hydel Power Project** under the PARIVESH 1.0 portal, so that the necessary subsequent actions may be initiated and completed without delay.

4. Additionally, the project proponent has affirmed that they have no objection to modification if the authority opts to update the user agency name, which would result in an automatic change of all three linked cases under the same login ID due to the system's inbuilt configuration.

5. Therefore, the matter is submitted for reconsideration by the competent authority for processing the proposal in the PARIVESH 1.0 portal.

Dhanwan Hydel Power Project under the PARIVESH 1.0 portal, so that necessary subsequent actions may be initiated & completed without delay. Also, project proponent affirmed that they have no objection of modification if the authority opts to update the user agency name, resulting in an automatic change of all three linked cases under the same login ID due to system inbuilt configuration. Therefore, the matter is submitted for re-consideration by competent authority for processing the proposal in PARIVESH 1.0 portal.

Sub: Request for considering the proposed Construction of 1MW HYDEL Power project in
Dhanwan in Parivesh 1.0-reg.

Ref: No. FC/HPB/01/74/20211/120015/2025 dated 04.07.2025.

Sir,

This is to respectfully submit that the proposal for construction of the 1 MW Hydel Power Project at Dhanwan was initially uploaded on the Parivesh 1.0 portal vide Online Proposal No. FP/HP/HYD/39107/2019, dated 24.02.2019. The submission was made by M/s Bhup Raj, bearing PAN No. AQZPR4507Q, and as per the PAN credentials, the system auto-filled the User Agency name as **Baada Deo Small Hydel Project Pvt. Ltd.**

Subsequently, due to personal circumstances, M/s Bhup Raj, the Director of Baada Deo Small Hydel Projects Pvt. Ltd., transferred ownership of the said project to **M/s Shivganga Hydel Power Project**. Accordingly, all relevant documents including the Techno-Economic Clearance (TEC), Implementation Agreement (IA), Connection Agreement, and other supporting documents have been duly prepared and uploaded on the Parivesh 1.0 in the name of the new User Agency, **M/s Shivganga Hydel Power Project**.

In this regard, it is respectfully submitted that the name change process pertaining to the proposed 1 MW Hydel Power Project was taken up in the REC meeting held on 30.06.2025. However, due to the existence of three separate proposals being processed under the same login ID, the system does not permit a change to the User Agency name that is M/S Shivganga Hydel Power Project. Any alteration to the login ID would automatically result in the change of User Agency name across all three linked proposals, thereby creating procedural inconsistencies.

Further, as per the directions received from the REC dated 30.06.2025, we are required to withdraw the existing proposal from Parivesh 1.0 and re-upload the complete documentation afresh on Parivesh 2.0. While we fully acknowledge and appreciate the intent to streamline processes through Parivesh 2.0, but transition poses significant procedural challenges at this stage.

Uploading the proposal on Parivesh 2.0 would necessitate revising then tire submission, thereby initiating a comprehensive process that would involve preparation of maximum nos of new documentations. This includes but is not limited to updated checklists, NOCs, maps, and other supporting materials as per the new portal's format and guidelines. The compilation and

validation of these documents is highly time-consuming and may lead to considerable delays in project execution.

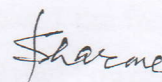
Therefore, it is respectfully requested that your esteemed office may kindly consider and process the proposal for the Dhanwan Hydel Power Project under the Parivesh1.0 portal, so that necessary subsequent actions may be initiated without delay. Furthermore, in the event that the authority opts to update the User Agency name, resulting in an automatic change across the three linked cases under the same login ID, we wish to submit that we have no objection to such modification and shall abide by the revised system entries accordingly.
