2. The point wise reply with respect to the observation raised by the Integrated Regional Office, Chandigarh, MoEF&CC vide letter referred to above is given as follows: -

Action taken by the State Government against the officials concerned for not being able to prevent the use of forest land for non-forestry purpose without prior approval of Govt. of India	In this regard, it is submitted that the High court violation copy order & 2183 Violation cases road list (appeared at Sr. No. 80) has been uploaded in Parivesh portal Part-I in additional information.
2.	The Joint Inspection Report for the instant proposal may be provided.	In this regard, it is submitted that The Joint Inspection Report for the instant proposal has been uploaded on Parivesh portal Part-II in additional information.
3.	In Part-I, Details of Divisions, the name of the Forest Division is written as Shimla (Shimla). The same may be clarified whether any forest division exists with this name as on date. The same may be reviewed and correct it accordingly	In this regard, User Agency has submitted that In Part-I detail of division, the of forest division is already mentioned in Parivesh Portal. The User Agency can not change this.
4.	In Part-I, A -3 (xvii) the name mentioned in the authorization letter does not match with details of the person making the application.	In this regard, User Agency has submitted that the revised authority letter has been uploaded on Parivesh portal Part-I.
5.	Administrative Approval of the project may be provided.	In this regard, User Agency has submitted that the Administrative Approval of project has been uploaded online in the Part-I under additional information details.

6.	The certificate regarding minimum use of Forest Land c/s by the concerned DFO may be provided	In this regard, User Agency has submitted that the minimum use of Forest Land certificate has been counter signed by DFO and uploaded online in the Part-I under additional information details.
7.	The layout plan indicating violated part and unviolated part with distinct color and c/s by concerned DFO may be provided	In this regard, User Agency has submitted that the layout plan indicating violated part and unviolated part with distinct color has been counter signed by DFO and uploaded online in the Part-I under additional information details.
8.	Details of Forest land including Khasra No. c/s by the concerned DFO may be provided.	In this regard, User Agency has submitted that the details of Forest land including Khasra No. has been counter signed by DFO and uploaded online in the Part-I under additional information details.
9.	Upon examination of the KML, it is observed that there is deviation in the KML from the existing path/road. State Govt. may clarify whether any new alignment has been proposed?	In this regard, User Agency has submitted that No new alignment has been proposed in this proposal.
10.	The certificate of beneficiaries provided has mentioned Five villages. However only 2 have been marked in the KML, the same may be reviewed and rectified.	In this regard, User Agency has submitted that the revised KML has been uploaded on Parivesh Portal Part-I.
11.	Penal NPV bill is required to be submitted as per the direction by MoEF&CC dated 06.01.2022	The bill of Penal NPV has been uploaded online in the Part-II under additional information details.
12.	The CA scheme of 1190 plants may be provided along with all the requirements.	The CA scheme of 1190 plants has been uploaded online in the Part-II under additional information details.
13.	As the road has been already constructed, DFO concerned may provide the undertaking that there will be no felling of trees involved in the instant proposal.	The Undertaking of DFO concerned has been uploaded online in the Part-II under additional information details. .
14.	As per DSS analysis, the proposed area for diversion is given 0.5944 ha, but as calculated on DSS Portal, it is found to be 0.46 ha. Therefore, necessary corrections in the KML file may be carried out. The revised KML file may be uploaded.	In this regard, User Agency has submitted that the DSS analysis KML file of proposed road showing in google earth is in shape is in linear shape, the width of this shape cannot be measured only the length width measured in KML file so, the area is not calculated as per the D.A.
