Point No. (1)	The reply of the Sl. No.10 of Govt. of Assam forwarding letter No. FRS.257/ 2018/ 37,dated. 24/12/2018. There is no violation of the Forest Conservation Act,1980 in the area proposed for diversion.
Point No.(2)	A fresh approach road is not required for running of the proposed 5 Ha. Madhupur Gravel Mahal because an existing forest road connects the extraction site of mining contract area with existing Uriamghat Ghulapani PWD Road.. A report received for DFO, Golaghat Division vide his letter No. A/RF Mahal/99-101,dated. 19/01/2019 is enclosed as Annex-I .
Point No. (3)	The proposed Compensatory Afforestation area is non forest Revenue Village land at Vill:-Monglai Phonglo, Mouza:- Amri, Block:- Diyungbra under Dima Hasao District, Assam as reported by DFO, Dima Hasao Forest Division (West) Haflong vide his letter No. FRS/G/CAMPA/Consolidation/2018-19/3616-18,dated. 24/01/2019 is enclosed here with as Annex-II






