Point No. (1)	The reply of the Sl. No.10 of Govt. of Assam forwarding letter No. FRS.249/ 2018/ 58,dated. 19/12/2018. There is no violation of the Forest Conservation Act,1980 in the area proposed for diversion.
Point No. (2)	Earlier Nakkati Hill Stone Quarry No.1 (Area 1 Ha.) was in operation as per approval of Govt. of India's letter No. 8-5-42/2003/RONE-AS/3119-21,dated. 18/11/2005 (Copy enclosed as Annex-I) where diversion of approach road was not included. Now, for extraction of Minor Mineral from the mining contract area of Nakkati Hill Stone Quarry No.1 (Area 5 Ha.) an approach road is required as per report received for DFO, Aie Valley Division vide his letter No. A/AVD/New Mining Area/91, dated. 17/01/2019 is enclosed herewith as Annex-II .

In view of the above, it is requested to kindly grant the "In-Principal Approval" in respect of the proposal for diversion of 5.0 ha of forest land for operation of **Nakkati Hill Stone Quarry No.1 under Aie Valley Division** at your earliest convenience.

Sir,

Please refer to the State Government's letter No. FRS. 74/2003/138 dt. 10.7.2003 and FG.27/Nodal/Mahal Proposal dt. 14.11.2005 on the subject mentioned above, seeking prior approval of the Central Government in accordance with section 2 of the FCA, 1980.

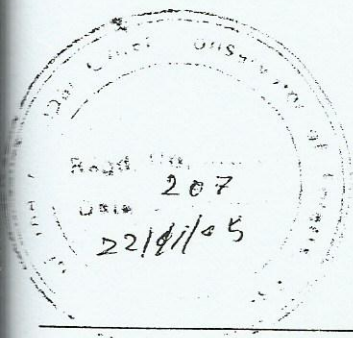
After careful consideration of the proposal of the State Government, the Central Government hereby conveys its approval for diversion of 2.0 ha (1.0 ha each) of forest land for renewal approval of 2 Stone Quarries under Aie Valley Division of Bongaigaon District, Assam on lease for a period of 5 years;

- (i) Nakkati Hill Stone Quarry No. 1 - Nakkati R.F - - 1.0 ha
- (ii) Nakkati Hill Stone Quarry No. 3 - Nakkati R.F - - 1.0 ha

The approval of these Mahals is subject to the fulfillment of the following conditions :-

- (i) The legal status of the forest land shall remain unchanged.
- (ii) All the funds i.e for NPV amounting to Rs. 5.80 lakhs and Rs. 5.80 lakhs respectively for each stone quarry received from the User Agency under the project shall be transferred to the Compensatory Afforestation Fund Management & Planning Agency (CAMPA). Till such time an appropriate Head of Account is communicated in this regard, such fund shall be kept in the form of Fixed Deposits in the name of the concerned DFO or Nodal Officer in any Nationalized Bank as per the guidelines issued by the Ministry of Environment & Forests Dated 22.3.2004.
- (iii) The State Govt. shall take all precautionary measures to ensure that the neighboring forests are not disturbed due to stone collection during the lease period.
- (iv) Suitable measures to be taken to prevent soil erosion as well as land slips due to quarry operation.

- (v) No labour camps shall be set up at the sites or in the Reserve Forest nearby for the labour involved in the extraction works.
- (vi) No stone crusher to be set up near National Highway.
- (vii) Reclamation plan to be prepared and submitted to this office for approval and the same be implemented when the lease period expires.
- (viii) There should not be any felling of trees.


Sir,
