Point No. (1)	The reply of the Sl. No.10 of Govt. of Assam forwarding letter No. FRS.251/ 2018/ 58,dated. 19/12/2018. There is no violation of the Forest Conservation Act,1980 in the area proposed for diversion.
Point No. (2)	The DFO Aie Valley Division, Bongaigaon has applied to the Deputy Commissioner Bongaigaon, cum Chairperson, District Level Environment Impact Assessment Authority for issuing Environment Clearance vide his letter No. A/AVD/Mahal/2018/2000-04,dated. 18/08/2018. (Copy enclosed as Annex-I)
Point No. (3)	A fresh approach road is not required for running of the proposed 5 Ha. Nakkati Hill Stone Quarry No.3 as the proposed area for extraction of minor mineral is adjacent to the existing forest road. 
