- 5.1 A proposal has been received by this office from Irrigation Construction Division, PMGSY. Purola for diversion under FCA-1980) of 2.0925 ha. (4.2260 ha Civil Land For Muc disposal for complete Road and 1.2825 ha for Road Construction Total 5.5085 ha in Civil Land Used) Total 11.673 ha (4.0725 ha of Uper Yamuna Van Prabhag Barkot + 2.0925 ha of Tonse Van Prabhag Purola) of forest land for non-forestry purpose. The project envisages the use of forest land for Construction of Naugaon Purola Motor Road Km. 2 to Thali Motor Road in District Uttarkashi, Under PMGSY. The site inspection of the land involved in the proposal has been done by me on dated 22.3.2018
- 5.2 On inspection of the site, it is found that the land required by the user agency is a RF/PF/un-classed/Other forests measuring 2.0925 ha.
- 5.3 The requirement of forest land as proposed by the user agency in Co1.2 part-1is unavoidable and is barest minimum required for the project.
