Point No. (1)	The reply of the Sl. No.10 of Govt. of Assam forwarding letter No. FRS.248/ 2018/ 57,dated. 19/12/2018. There is no violation of the Forest Conservation Act,1980 in the area proposed for diversion.
Point No. (2)	A fresh approach road is not required for running of the proposed 5 Ha. Bhairab Hill Stone Quarry as the proposed area is a zero distance from the PRF boundary and there is existing PWD road. A report received for DFO, Aie Valley Division vide his letter No. A/AVD/New Mining Area/94, dated. 17/01/2019 is enclosed herewith Annex-I .






