With reference to the above cited memo on the captioned subject, the compliance of the observations raised by the Deputy Conservator of Forests, (Nodal), O/o the Principal Chief Conservator of Forests & HoFF, Odisha, Bhubaneswar in respect of this Division is furnished herewith for favour of kind information and necessary action.

Point No. 1:

The required forest land of 5.127 Ha. (Boudh Division 0.29 Ha. + Athmalik Division 4.837 Ha.) proposed for diversion has been rectified in Form-A (Part-I), Part-II and Site Inspection Report of this Division and are enclosed in DP.

Point No. 2:

The total requirement of non-forest land of 44.412 Ha. (Boudh Division 9.044 Ha. + Athmalik Division 35.368 Ha.) has been updated in Form-A (Part-I) in web portal.

It is to clarified here that, the requirement of non-forest land in respect of this Division of 9.06 Ha. has been rectified to 9.044 Ha. due to elimination of duplicate Plot no. 199 of Khata No. 19 of Mouza Pipalkata in Form-A(Part-I) and the rectified land schedule duly authenticated is enclosed in DP. Hence, the requirement of non-forest land in respect of this Division may be treated as 9.044 Ha. instead of 9.06 Ha..

Point No. 3:

The land scheduled of both forest and non-forest with 25.10.1980 certificate in respect of this Division has been countersigned by the undersigned and is enclosed in DP.
