It is submitted that the Prl.Chief Conservator of Forests, A.P., Guntur vide reference 4th cited has requested to re-examine the proposal and submit the same with due recommendations for taking further action in the matter.

In this context, the District Forest Officer, Kakinada vide ref.6th cited reported that the proposals for re-examination were forwarded to the Forest Range Officer, Rampachodavaram and Forest Range Officer, Addathigala. As per their reports the proposals for diversion of **6.004 ha** in Reserved Forests of Rampachodavaram Range (2.649 Ha) and Addathigala Range (3.3555 Ha) for formation of **road from Kota to Chintalapudi** in favour of the EE, TW Division, Rampachodavaram **may not be recommended** as the route is very narrow between stream and hill portion upto 2.00 km and road cannot be laid without

undertaking blasting in the forests which is not permitted as per Forest Conservation Act, 1980 and 328 no of tree to be felled for creation of this road. Further adverse impacts would be there on in the form of damage to thick and dense vegetation of semi evergreen forests and there would be fragmentation of wildlife habitats as leopard, bison, sloth bear, barking deer, sambar etc., are found in these areas. Hence, the proposal is **not recommended**.

In view of the above circumstances, the report of the District Forest Officer, Kakinada may be considered. A copy of the report of the District Forest Officer, Kakinada vide ref.6th cited is enclosed herewith for kind perusal.

It is to inform that, the proposals for diversion of 6.73 ha Forest Land for formation of **Road from Kota to Chintalapudi** passing through the Reserved Forests of Kakinada Division for in favour of the Executive Engineer, Tribal Welfare Division, Rampachodavaram were forwarded by the Principal Chief Conservator of Forests (HoFF), Andhra Pradesh, Guntur in the reference 1st cited, for examining and to submit the remarks and recommendations. Accordingly, the road proposals were verified on the field and the proposals were not recommended, vide reference 2nd cited.

Further, the Principal Chief Conservator of Forests(HoFF), AP, Guntur and Conservator of Forests, Rajahmundry Circle, Rajamahendravaram have issued instructions, vide reference 3rd & 4th cited, for re-examination of the proposals for taking further action in this regard. Accordingly, the Forest Range Officer, Rampachodavaram has submitted report vide references 5th cited.

In this connection, it is submitted that, the proposals for diversion of 6.004 Ha in reserve forests of Rampachodavaram range (2.649 ha) & Addateegala range (3.3555 ha) for formation of road from Kota to Chinthalapudi in favour of the Executive Engineer, TW Division, Rampachodavaram may **not be recommended** as the route is very narrow between stream and hill portion upto 2.00 km and road cannot be laid without undertaking blasting in the forests which is not permitted as per F(c) Act, 1980 and 328 number of trees to be felled for creation of this road. Further, it is submitted that, the adverse impacts in the form of damage to thick and dense vegetation of semi- evergreen forests and habitat fragmentation of the wildlife habitats as leopard, bison, sloth bear, barking deer, sambar etc., are found these areas. It is submitted that, the proposals for diversion of 6.73 ha Forest Land for Laying of WBM Road from Kota to Chintalapudi passing through the Reserved Forests of Kakinada Division for in favour of the Executive Engineer, TW Division, Rampachodavaram were forwarded by the Principal Chief Conservator of Forests (HoFF), Andhra Pradesh, Guntur in the reference 1st cited, for examining and to submit the remarks and recommendations.

Further, I submit that, the proposals were forwarded vide reference 4th cited to the Forest Range Officer, Rampachodavaram & Addateegala for field verification duly obtaining the hard copies from the user agencies vide reference 3rd cited. Accordingly, the Sub-Divisional Forest Officers, Rampachodavaram & Yeleswaram and the Forest Range Officers, Rampachodavaram and Addateegala have submitted reports vide references 5th & 6th cited and the details are as follows.

Further, the Site inspection was conducted on 26-12-2018 by me along with concerned staff. As per my field inspection and inspection reports of the concerned staff and as per the proposals submitted by the user agency the following are the observations.

The proposed area is passing through the Rampachodavaram Range (2.649 ha) and Addateegala Range (3.3555) i.e., total area in Kakinada division is 6.004 ha.

I. Rampachodavaram Range:

1. There is an existing gravel road from **Kota to Chintalapudi** with a width of **7.50** mtrs over distance of **3532** mtrs in Chintalapudi enclosure of **Rampachodavaram** Range. Balance area i.e., Comp.no.239, 240 & 243 of Kota RF of **Addathegala** Range.
2. The user agency submitted proposals for providing road over a length of 3532 mtrs and 7.50 mtrs width.
3. The location map showing the existing road and showing the area required for the road are submitted for kind perusal.

4. No tree growth clearance is required for laying of the road as this is an existing road.

The road facilitates the transportation of food grains and other daily commodities and to avail the medical and educational facilities for the Interior tribal villages to the Mandal headquarters, Y. Ramavaram and Sub-Divisional head quarters.

II. Addateegala Range:

The road starts at N.17.62219 ° E 81.86690 ° & ends at N.17.63671 ° E.81.83955°. The Road is proposed through Kota RF. Total length proposed is 4.474 KM to a width of 7.50 mtrs. Thus the total area required is 3.3555 ha. The main vegetation consists of Konda thangedu (*Xylia xylocarpa*), Nallamaddi (*Terminalia tomentosa*), Gumpena (*Lannea coromandelica*) Nallagatha (*Diospyros sylvatica*), Kondagogu (*Cochlospermum religiosum*). Area Details are as follows.

The proposed road from Kota to Chintalapudi in East Godavari District is to a length of 4.474 km is falling in Comp.No.240, 239 and 243 of Kota RF and the Density of vegetation is 0.8. The proposed road starting with N.17.62219 ° E 81.86690 ° & ends at N.17.63671 ° E.81.83955°. The Misc Trees 328 Nos has to be removed at both sides of road (132.04 cmt) and the value of trees is Rs.20,45,578/- and the sand gravel to be dug up for laying is 10992 cum @ Rs.550/- per cum and the value of sand gravel is Rs.60,45,600/- (Statement is enclosed).

The proposed BT surface to the road from Kota to Chintalapudi in East Godavari District will have adverse impacts in the form of damage to thick and dense vegetation of semi- evergreen forests and habitat fragmentation of the wildlife habitats as leopard, bison, sloth bear, barking deer, sambar etc., are found these areas.

Hence, the user agency for diversion of 6.004 Ha in reserve forests of Rampachodavaram range (2.649 ha) & Addateegala range (3.3555 ha) for formation of road from Kota to Chinthalapudi in favour of the Executive Engineer, TW Division, Rampachodavaram may **not recommended** as the route is very narrow between stream and hill portion upto 2.00 km and road cannot be laid without undertaking blasting in the forests which is not permitted as per F(c) Act, 1980 and 328 number of trees to be felled for creation of this road. Further it is submitted that the adverse impacts in the form of damage to thick and dense vegetation of semi- evergreen forests and habitat fragmentation of the wildlife habitats as leopard, bison, sloth bear, barking deer, sambar etc., are found these areas.
