It is submitted that the Prl. Chief Conservator of Forests, A.P, Guntur vide ref 1<sup>st</sup> cited requested to re-examine the issue in co-ordination with District Administration and submit with specific recommendations in respect of the proposals for diversion of in 1.69 ha forest land in compartment no.23 & 26 of Maduguru R.F in Chintur Range of Chintur Division for formation and providing BT to the Road from ZP Road at Alligudem to Staffordpeta in favour of Executive Engineer, PR (PIU), Kakinada.

The Divisional Forest Officer, Chintur vide ref.5<sup>th</sup> cited reported that the above said road proposal was re-examined in co-ordination with the Project Officer, ITDA, Chintur and found that the proposed road project would lead to further encroachments by Gothikoya non-local tribals migrated from Odisha and Chattisghar States. Hence, the Divisional Forest Officer, Chintur has reported that there is no necessity for providing BT to the road from Alligudem to Staffordpeta which will adversely affect the forest wealth situated in the vicinity of the proposed forest land for diversion.

In view of the above circumstances, the report of the Divisional Forest Officer, Chintur may be considered. A copy of the report of the Divisional Forest Officer, Chintur vide ref.5<sup>th</sup> cited is enclosed herewith for kind perusal.

It is submitted that, the Executive Engineer, Panchayath Raj(PIU) Division, Kakinada in the reference 1<sup>st</sup> cited, has uploaded the proposal (FORM-A, Part-1) in PARIVESH web portal and submitted hard copies of the proposal for diversion of Forest Land 1.69 Ha. in Compt.No.23 & 26, Maduguru & Kalleru R.Fs. of Chintur Division for formation and providing BT to the Road from ZP Road at Alligudem to Staffordpeta. The same proposal was verified on the field and submitted Part-II information to the Chief Conservator of Forests, Rajahmundry by recording "non- recommendation" inview of the specific conditions at field level vide this office reference 2<sup>nd</sup> cited. Inturn, the Chief Conservator of Forest, Rajahmundry has addressed same to the Prl. Chief Conservator of Forests, A.P., Guntur for taking further action. After verifying the same and basing on request of the District Collector, East Godavari District, the Prl. Chief Conservator of Forests, A.P., Guntur in the reference 3<sup>rd</sup> cited, has requested this office for re-examination of road issue in coordination with District Administration and resubmit the proposal with specific recommendation.

Inview of the above, it is submitted that, the providing BT to the Road from ZP Road at Alligudem to Staffordpeta issue was re-examined in coordination with the Project Officer, I.T.D.A. Chintur and the following few points are submitted for kind perusal.

- > The Alligudem is an illegal Gothi Koya habitation situated in Compt.No.26, Kalleru RF. and Stafordpeta is located in Compt.No. 23, Maduguru R.F, Chintur Range of Chintur Division.
- The Gothi Koyas are the migrated tribes from Odisha and Chattisgrah States, these migrant non- local tribes have influxed into the Reserve Forest areas of Chintur Division before state bifurcation and occupied the large areas of forest land by clearing the tree growth and made their settlements permanently in the said forest area. These tribal people are habitual in clearing the forest tree growth gradually by girdling the trees and later on setting fire. Their number increased disproportionately in this habitation when compared to the relatively small habitation Staffordpeta, which is originally occupied by local tribes but later on occupied by Gothi Koyas. The number of families existing in this village is around 15 only.

- There existing only WBM road from Maredumili to Chintur Road to Alligudem (enclanded habitation) 4.30 Kms. out of which 1.66 Kms. falls under Reserve Forest. There is no point in having a BT Road from Alligudem to Staffordpeta without having BT road for the above stretch.
- Providing BT Road between Alligudem encroached habitation and Stafordpeta illegal habitation will lead further encroachment upto A.P. state border. Further, it is submitted that, there are no revenue villages in-between said illegal Gothi koya habitation and upto the state border of Andhra Pradesh.
- Any development activity provided in the said area will open doors to the encroachers for further encroachment of Reserve Forest land, which adversely affect on the forest wealth.

Inview of the above, it is submitted that, there is no necessity to provide BT to the road from Alligudem to Stafordpeta Gothi koya encroached habitations.

Hence, I request the Conservator of Forests, Rajahmundry to kindly address the above issue to the Prl. Chief Conservator of Forests, A.P., Guntur for taking further action in this matter, as there is no necessity for providing BT to the road from Alligudem to Staffordpeta which will show adverse effect on Forest wealth situated in the vicinity of said proposed diverted Forest land.
