

Though in reply it is mentioned that village wise breakup details have been uploaded at B-2.3 Part- I online but still breakup of forest land in the four villages has not been found uploaded online at B-2.3 Part-I online.	The village wise breakup has been corrected and uploaded at Part I B 2.3 of Form A. Villager other than mayali which were mentioned earlier were only being benefited by proposed. Forest land of these villages will not be diverted for proposed road.
2	In reply to point no.5 of EDS dated 31.03.2016, it is mentioned that the muck is likely to be disposed in private land and NOC of the land owner Jaikrishan Saklani has been uploaded at additional document at S.No.2 of Part-I online.
