With reference to the Government of India letter 7<sup>th</sup> cited, I wish to inform the following.



1) Government of India has pointed out in Chengalpattu District, 5 different compensatory afforestation area of non-forest land of about 69.705 ha for previously approved projects are yet to be notified as RL/RF and requested to provide a copy of notification of non-forest land as PF/RF at the earliest for further consideration of the proposal.

2) In this regard, I am to state the following.

i) Two proposals involving, 41.62 ha of non-forest area (27.38 ha and 14.24 ha) has already been notified under Section 4 of the Tamil Nadu Forest Act, 1882 vide G.O. Ms No. 145, Environment, Climate Change and Forest (FR.13) Department dated 13.10.2023 and action is being pursued by the Forest Settlement Officer, Tiruvallur to complete the settlement process as laid down under the Tamil Nadu Forest Act, 1882 as Reserved Forests. Copy of the above Government Order is enclosed herewith.

ii) One proposal involving 20.25 ha, for notification of non-forest area under Section 4 of Tamil Nadu Forest Act, 1882, proposal has been sent to the District Collector, Chengalpattu in District Forest Officer, Chengalpattu Division C. No. 6857/2003/D, dated 22.01.2024 and reminded on 11.07.2024. Action is being pursued by the District Forest Officer for the recommendation of the proposal of the District Collector to the Chief Conservator of Forests, Chennai Circle.

iii) One proposal involving 6.155 ha, the District Collector, Chengalpattu has sent the proposal to Principal Chief Conservator of Forests through the Chief Conservator of Forests, Chennai Circle on 08.02.2022. Shortcomings noticed and additional documents required on the proposal has been called for on 22.03.2022 (copy enclosed) and the details are yet to be received from the District Forest Officer, Chennai and Chengalpattu Divisions. The District Forest Officer, Chengalpattu has reported that, the land mutation documents in favour of Forest Department is awaited from the user agency, since the Adangal Register extract submitted with the proposal on the ownership of land is in the name of Individual name only. Action is being taken to notify the land under Tamil Nadu Forest Act, 1882 early.

iv) One proposal involving 1.68 ha, the District Collector, Chengalpattu has sent the proposal to Principal Chief Conservator of Forests through the Chief Conservator of Forests, Chennai Circle on 08.02.2022. Shortcomings noticed and additional documents required on the proposal has been called for on 22.12.2022



(copy enclosed) and the details are yet to be received from the District Forest Officer, Chengalpattu Division. Action is being taken to notify the land under Tamil Nadu Forest Act, 1882 early.



I am sending herewith the status report of the notification of non-forest area of Chengalpattu Division in the enclosed statement.





**APPENDIX.**

**NOTIFICATION – I.**

In exercise of the powers conferred by section 4 of the Tamil Nadu Forest Act, 1882 (Tamil Nadu Act V of 1882), the Governor of Tamil Nadu hereby declares that it is proposed to constitute the land within the boundaries specified in the schedule below as reserved forest and appoints the Tahsildar (Forest Settlement) Thiruvallur, ex-officio, to be the Forest Settlement Officer to exercise the powers under clause (c) of the said section in respect of that land.

**BOUNDARIES.**

**North.**- The boundary starts from the tri-junction point of village No.4, Pallavaram Contonement, No.15, Thrisoolam village and Survey No.1/1 of No.16, Jamin Pallavaram village and generally runs towards Southeast along the common village boundary of No.15, Thrisoolam village and No.16, Jamin Pallavaram village (at Survey No.1/1) and reaches the tri-junction point of No.15, Thrislooam village and Survey No.1/2 and 1/1 of No.16, Jamin Pallavaram village.

**East.**- Thence, the boundary generally runs towards southwest along the Northwest and Western boundary of Survey No.1/2 of village No.16, Jamin Pallavaram village and meets the bijunction point of Survey Numbers 1/1 and 1/2 of No.16, Jamin Pallavaram village.

**South.**- Thence, the boundary generally runs towards west along the Northern boundary of Survey No.1/2 of No.16, Jamin Pallavaram village and meets the bijunction point of Survey Numbers 1/1 and 1/2 of No.16, Jamin Pallavaram village.

**West.-** Thence, the boundary generally runs towards north, west, north, northeast and west along the eastern, northern, eastern and northern boundary of Survey No.1/2 of No.16, Jamin Pallavaram village. Thence the boundary runs towards northeast and west along the southeastern and northern boundary of block 2, No.16, Jamin Pallavaram village and thence runs towards northeast along the southeast boundary of village No.4, Pallavaram Condonement and reaches the starting point.

**NOTIFICATION – II.**

In exercise of the powers conferred by the last paragraph of Section 4 of the Tamil Nadu Forest Act, 1882 (Tamil Nadu Act V of 1882), the Governor of Tamil Nadu hereby appoints the District Forest Officer, Chennai Division, Chennai ex-Officio to attend on behalf of the Government at the enquiry prescribed under Chapter-II of the said Act, in respect of the land of Jamin Pallavaram Forest Block proposed to be constituted as reserved forest.




