In inviting a reference to GoI, MoEF& CC, Regional Office, Bhubaneswar letter cited above on the captioned subject, the DFO, Rayagada Forest Division and RCCF, Koraput Circle have furnished the compliance as furnished below-:

Observation-a: The user agency has not submitted KML file of entire alignment of proposed Y-connectivity project.

Compliance: In compliance to the above the RCCF, Koraput Circle has reported that the user agency has now submitted the KML file of entire alignment of proposed Y-connectivity of the proposed railway line project in a CD form which is enclosed herewith for reference as Annexure-A.

Observation-b: As per DSS analysis, agricultural encroachment and non-metalled road are observed in the CA patch. This may be clarified by the State Govt. in view of the suitability of CA land and encroachment free land.

Compliance: In compliance to the above the RCCF, Koraput Circle has reported that the Range Officer, Muniguda Range under Rayagada Forest Division has mentioned in his inspection report vide his memo No.1131 dated 08.11.2023 that the Compensatory Afforestation land is free from encroachment and the non-metalled road observed is a temporary footpath used by local villagers which is enclosed herewith as Annexure-B.

In addition to that the User Agency has applied for diversion of forest land to a tune of 1.148 ha of forest land required for this project for which CA land has been submitted over 1.416 ha against the above project which is more than the area proposed for diversion as has been reported by the DFO, Raygada Forest Division vide his memo No.4538 dt.08.11.2023 which is enclosed herewith as **Annexure-C**.

In this context, the compliance to the observations dated 29.09.2023 of Government of India, MoEF& CC, Regional Office, Bhubaneswar is sent herewith for favour of kind information and necessary action.
