

Only the conductor of route length of 12mtr. in the survey no.45, Sonegaon (Rithi), Bhivapur & 06 mtr in the survey no. 70, Kalandri (Rithi), Bhivapur passing through the Zudpi Jungle (Revenue Forest Land) is done unknowingly by the contractor. However, the line is not charged therefore there is no electrolocation and danger to the wildlife animals. The line will be charged after getting all the statutory approvals from the competent authority i.e Forest, Railway, S.E Electrical etc. Also the work is carried out without doing any type of excavation and without felling any Trees and without disturbing wildlife. Due to this unknowingly work in the forest area, the work order is suspended and warning letter is issued to the agency and the Sub-Division Incharge.

The 95% of the work of Transmission line in the Nagpur Jurisdiction is completed except at Zudpi Jungle Forest area at Vg. Sonegaon (Rithi) and Kalandri (Rithi). The conductor of line was lying outside the said forest area. Being a theft prone area and dangerous to the public of Village Sonegaon (Rithi) and Kalndri (Rithi) as well as to the wildlife if any, it was necessary to lift the conductor and the conductor was lifted unknowingly being the forest area by the contractor to avoid theft and any undue incidence to public and wildlife without disturbing the forest land / Trees and wildlife.

As the proposal is for construction of transmission line and there is no suitable alternative for the same and the project is for the Public at Large, the proposal be considered for further processing and requested to process the compliances already submitted by this office and arrange for submission to the competent authority so that the Stage-I approval may be granted at the earliest.
