





**Sub:** Permission for Canal Crossing in between RD 60 and 61 of RGLC by Fatehgarh II - Bhadla II 765 KV D/C line associated with "Transmission System associated with LTA application from Rajasthan SEZ Part B under Tariff based competitive bidding (TBCB)  
**Ref:** Your letter no. 5148 dated 1.7.2020

In above reference, it conveyed, that aforesaid permission has been granted by the Administrative Department vide ID No PS/PHED & GWD/20/1774 dated 13.8.2020 to the proposal of Powergrid Fatehgarh Transmission Limited (a 100% wholly owned subsidiary of Power Grid Corporation of India Limited, a Government of India Enterprise) for crossing of power transmission line over Rajiv Gandhi Lift Canal between RD 60 & 61, keeping towers outside the land width of PHED. The permission is granted based upon the Affidavit given by applicant and subject to following conditions:

1. they shall maintain minimum clearance of 23.491 m for the lowest conductor under the maximum sag condition of 85° C, above the canal bank & shall follow all safety precautions as per relevant code.
2. they shall be solely responsible for stability and safety of transmission line.
3. in future, if any tower is required to be shifted due to widening/modification of RGLC, then they shall be liable to shift the poles & all the cost for shifting of towers shall be borne by them.


